Responding to Delinquency Through a Continuum of Care & Alternatives to Youth Incarceration: An OJJDP Approach to Youth Success - This session will ensure that practitioners have a broader array of community-based options to keep children at home and in their communities. OJJDP will highlight what the research says works, showcase best practices for youth serving programs, and discuss how utilizing a continuum of care to meet youths' needs can pay dividends for youth, families, and their communities. The session will go over the OJJDP FY 2023 Building Local Continuums of Care to Support Youth Success initiative, which provides funding to state and local jurisdictions that have high rates of youth incarceration to develop a continuum of care that includes a focus on positive youth development, prevention, diversion, and treatment services. This continuum of care will enhance communities' ability to meet the needs of youth involved in or at risk of entering the juvenile justice system through community-based strategies, thereby reducing reliance on deeper system involvement to access resources. This initiative will also work to identify ways to strategically reinvest any cost savings into strategies and programs that are most effective at reducing delinquency and recidivism.

How an Untraditional Partnership in Colorado Ended the Arrest of Youth for Low-Level Offenses and Dramatically Reduced Youth Crime - This session will explore a promising

REGIONS OF STATE ADVISORY GROUPS

The composition of the JJDPAs State Advisory Groups (SAGs) regions is defined in the CJJ Bylaws. Each region's members are represented on the CJJ Executive Board by a Regional Chair and 1-to-2 Regional Representatives. Memberships in CJJ are granted to all SAG members, as well as the state staff that work on JJDPAs matters with the SAG (including the state Juvenile Justice Specialists, DMC Coordinators, and Compliance Monitors).

The Chair/Chair-designee of each CJJ member-SAG has a vote in all proceedings of the CJJ Council of SAGs. The Council is responsible for Bylaws, electing Officers to the Board, and approving major policy positions. The Council of SAGs shall meet at least once annually. The CJJ Executive Board convenes at least 4 times per year to act as the governing body for legal, fiscal and strategic decisions, reflecting the views of CJJ members and stakeholders.
