#### **Call Notes**

- The purpose of this weekly coordination call is to share COVID-19 information, news, and resources with Union County's business community.

### **Small Business Administration**

Jerome Jones, Lender Relations Specialist

- The SBA Economic Injury Disaster Loan (EIDL) Program allows eligible small businesses and non-profits to apply for low-interest loans of up to \$2 million.
- Terms: 3.75% for businesses and 2.75% for non-profits; depending on qualifications. 30-year repayment period.
- Once a complete application is submitted it will take approximately 30-35 days for dispersal
  of funds. There are no payments due for 11 months. Successful applicants will have six
  months to accept the loan.
- Applicants are encouraged to apply online: https://disasterloan.sba.gov/.

#### **Union County Health Department**

Jason Orcena, Health Commissioner

- Union County has two confirmed cases of COVID-19 and one additional probable case.
   Testing is very limited and is reserved for those who are critically ill or healthcare workers who are ill.
- Employers are urged not to make testing a condition of employees returning to work or being approved for sick leave. Any employee that is sick needs to be sent home.
- Regarding the Stay-at-Home Order, the Health Department cannot determine which
  businesses are essential. Employers must make their own decisions and should answer two
  questions: is the business truly essential, and if so, is it safe to be open? Employers should
  consult the text of the Governor's Order and their legal counsel. For businesses that close,
  employees may maintain critical inventory or physical plant, but no clients/customers are
  permitted. Employees should be instructed to take precautions such as practicing physical
  distancing, regular cleaning, and staying at home if sick.
- Local law enforcement is responsible for enforcing the Stay-at-Home Order, and the Health Department is responsible for investigating complaints.

### **Union County Emergency Management Agency**

Brad Gilbert, Director

- The Union County EMA is a County agency tasked with planning, training, and conducting
  exercises to prepare the community for disasters. Once a disaster occurs, the EMA works to
  promote communication, collaboration, and information sharing among various departments
  and first responder agencies.
- Due to the COVID-19 pandemic, the Union County Emergency Operations Center (EOC) was opened two weeks ago. Approximately 70 of Ohio's 88 counties have opened their EOCs. The EOC is staffed by representatives of the Union County Health Department, fire/EMS, law enforcement, and EMA.
- The greatest need right now is Personal Protective Equipment (PPE) such as gloves, masks, and gowns. Any business able to donate these items can contact the EMA.

#### **Union County**

Steve Stolte, County Commissioner

• The Union County Commissioners applauds the collaboration that is occurring throughout the community. They also sympathize with businesses and residents enduring hardships because of the pandemic. Union County government remains functional. Many offices have implemented limited office hours and have instructed employees to work from home. Anyone who needs to conduct in-person business with a county office is urged to call ahead first.

# City of Marysville

Terry Emery, City Manager

- The City encourages residents to follow its social media outlets for the latest updates. The
  City continues to operate essential services such as police, fire, EMS, water and wastewater,
  and waste collection. City-owned buildings are closed to the public and some employees are
  working from home. Parks are open but restrooms and playgrounds are closed.
- The City has also implemented live streaming of City Council meetings. The City Council
  meeting on April 13th has been canceled and all other City board and commission meetings
  are postponed but will be reconvened if urgent matters warrant.
- The income tax filing deadline has been postponed until July 15th. No penalties or interest
  will be accrued during this time. Residents wishing to file their income taxes are encouraged
  to use the drop-box at City Hall. Additionally, utility disconnections have been suspended.

### Village of Plain City

Nathan Cahall, Village Administrator

- The Village declared an emergency last week. Village offices are closed to the public but operational as the village has prioritized essential operations and public health and safety during the pandemic.
- Utility disconnections have been postponed. All board and commission meetings are canceled. The income tax filing deadline is based on the State's schedule, so the April 15th deadline may change depending on pending action from the Ohio Legislature.

## Union County-Marysville Economic Development

#### OhioMeansJobs - Union County

The State has expanded the flexibility of the unemployment programs. It has shortened the waiting period for benefits, waived penalties for late payments, and is allowing employees who have lost employment due to the pandemic to seek unemployment benefits. Additional disaster-based unemployment assistance may be coming soon from the State, including potential eligibility for home-based employees.

Employers and residents seeking unemployment benefits are encouraged to visit the State's website: <a href="https://unemployment.ohio.gov/">https://unemployment.ohio.gov/</a>. The State has expanded its office hours to 7:00 – 7:00 PM Monday through Friday. Additional staff has been added to the local Ohio Means Jobs – Union County office, too, although many employees are now working from home. Anyone needing assistance are urged to call ahead first.
