Certification of Inability to Operate Due to Lack of Quorum North Lafourche Conservation, Levee and Drainage District

The North Lafourche Conservation, Levee and Drainage District (NLLD Board of Commissioners) has scheduled Finance and Priority Committee and Regular Board monthly meetings for April 21, 2020. Such meetings must occur on April 21 to assure that the District meets its financial obligations to its Contracting Engineers & Contractors who are classified as providing "Essential Services" to the District and other vendors that provide goods and services in support of our operations.

In an effort to reduce and limit the spread of COVID-19 in Louisiana, and to preserve the health and safety of all members of the public, the Governor has declared the COVID-19 Public Health Emergency and ordered that it is necessary to limit public gathers in a single place at the same time in an effort to avoid individuals being in close proximity to one another. As a result of the public emergency, the limitations imposed on public gatherings and personal interactions, and the need for a number of members to travel to any physical meeting location where confirmed cases of COVID-19 have occurred, the Executive Director of the North Lafourche Conservation, Levee and Drainage District hereby certifies that in order to protect the lives, property, health, safety, and welfare of the citizens of Louisiana, it is necessary to conduct the NLLD Regular Monthly Meetings on April 21, 2020 by teleconference or video conference in order to assure the presence of a quorum of the board members and to timely approve the payables of the District and other pertinent matters.

Therefore, in accord with Section 4 of Governor's Proclamation Number JBE 2020-30: Additional Measures for COVID-19 Public Health Emergency, the President of the North Lafourche Conservation, Levee and Drainage District Board of Commissioners will hold its April Regular Monthly meetings via Audio / Video Teleconference in a manner that will allow for observation and input by members of the public, as set forth in the notice posted on April 20th, 2020. All other open meeting law requirements have been met.

The board meeting's only agenda items will be for the approval of Minutes of prior meetings (for publication) and the individual items needed for contract issues and payments. Public comments will be accepted during the meeting.
