COMMUTE OPTIONS

CARPOOLS

BIKING AND WALKING

Biking and walking are great ways for employees to commute as it allows for social distancing and provides health physical and health benefits.

WORKING FROM HOME POLICIES

Many employers plan to continue to allow employees to work from home permanently or part-time to reduce onsite numbers. Now is the time to create a comprehensive, formal, telework policy.

PUBLIC TRANSIT

Public transportation has been deeply impacted by the COVID-19 outbreak. While concerns may currently exist regarding health and safety, public transit will remain an essential mode for millions of people. A vanpool typically consist of four to 15 coworkers who meet at a central location to board a newer van or SUV – sometimes equipped with Wi-Fi, GPS and satellite radio – and travel to and from work together. Passengers use their commute time to read, relax or work, and participants usually take turns driving. The vanpool vendor provides 24-hour roadside assistance, insurance and scheduled maintenance.

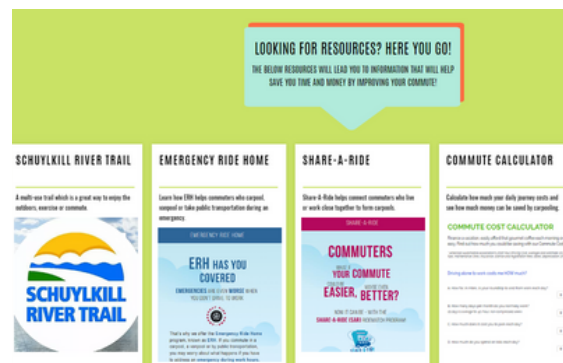
Educational Employee Emails
