About Us: From our board of directors and community volunteers to each member of the professional team, we are united around the fundamental premise that children have the right to be safe and protected from harm. The CAC works in close collaboration with the Child Protection Unit of the Northwestern District Attorney's Office to minimize secondary trauma to child victims by streamlining the handling of cases of child sexual abuse, physical abuse, and exploitation so that services can be coordinated more quickly and effectively for the victim and their non-offending family members. In our facility, we provide a safe, child-friendly atmosphere, designed to meet the needs of victims of abuse and the agencies involved in child abuse investigations. The CAC's current annual operating budget is approximately \$1 million.

CACFNQ is an accredited member of the National Children's Alliance. It is an independent, non-profit corporation funded by community donations and grants (federal, state, county, and city) specifically to (1) prevent "system" re-traumatization of child abuse victims, (2) provide a multidisciplinary team approach to address the needs of child abuse victims, an (3) to educate the community to prevent child abuse.
