

# Grim Milestone

- More than 100,000 Americans died of overdoses in the one-year period leading up to April.
- An almost 30% jump from the prior year, according to data released this week by the National Center for Health Statistics.
- That startling figure exceeds the number of traffic and gun fatalities combined.

- The Times spoke to Sam Quinones, who chronicled the drug trade in the 2015 book “Dreamland: The True Tale of America’s Opiate Epidemic,” and most recently explored the evolution of the epidemic in [his new book](#) “The Least of Us: True Tales of America and Hope in the Time of Fentanyl and Meth.”
- “They’re mixing with meth, mixing with cocaine, and now we’re seeing reports of mixing with marijuana. Everybody selling knows that you just add fentanyl to your mix — whether you’re selling cocaine or meth, it doesn’t matter — and pretty soon, you’re going to get a fentanyl addict who will buy from you every single day.”
- “We’re living in a very, very different world. It used to be that shifts would take place over decades: the ’70s were depressants; the ’80s was crack, stimulants; the ’90s, well, you didn’t really know. And so now it’s all together and all at the same time — in catastrophic quantities.”





**Activity:** Starting March 1st, we have been putting together resources in the local area to determine baseline referrals. We have and are continuing to meet with POC's at several Hub & Spokes to help streamline the referral process once we have identified a MAT/PolySub client who is ready for treatment. We have printed all posters in color and they are hung in the common areas, group rooms and offices. We have printed all Client Handouts in color and are displayed in lobby, common areas, group rooms, and offices. They are also added to ALL intake files along with Client Information Letter and DAST Assessments. We are getting into rhythm with conducting DAST Assessments. In MAY West Covina has achieved 100% of Pre-screens conducted at intake. We are ensuring that everyone in Groups and/or Waiting Areas are being notified about free resources related to DUI MAT. Those that have yet to take the DAST and sign letter, are being asked to do so at that moment. All MAT Counselors have their MAT Toolkits and have been getting more acquainted with the contents and all resources. Staff has been attending Launch Meetings, LA County Providers Meetings and MAT Team Meetings to ensure that they are all knowledgeable of the resources and tools they have to offer their clients as well as their roles and responsibilities throughout the contract term.

#### SOW 6B - Case Management Framework

##### Enter activity, resources, and achievements applied to Deliverable B.

**Activity:** We have flyers, posters and MAT Toolkit material printed in high quality paper and in full vibrant color. In addition, toolkits were put into Binders and given to each DUI MAT Counselor. All DUI MAT Counselors have reviewed the toolkits and have acquainted themselves with resources. They have continued to add resources and POC's through contacting Hub & Spokes in their respective Areas. Some Counselors have not only spoken to their POC's over the phone, but have also visited the facilities in person to get a better understanding of the referral process, tour the facilities, gather program literature and exchange program information. All clients are given client handouts in color and provided with details of the DUI MAT Program. For those that state that they don't have any issues, we inform them that they can also share the handouts and info with their families and friends let them know about these free resources available to All. We also reassure them that they can always come talk to us should they need more information at a later time. We have created 18 files in advance(8 per Site: 3 English 2 Spanish) with complete case management paperwork (Confidentiality form, Demographic Info, Referrals, Copies of required paperwork for all clients agreeing to second level assessment. (The File Order Sheet is attached to the front of each file to use as they check off documents in file)

#### SOW 6C - MAT Toolkits

##### Enter activity, resources, and achievements applied to Deliverable C.

**Activity:** Mat Toolkits were printed on high quality paper and in vibrant color, placed into binders and labeled for Admin Staff as well as for Counselors to use as a resource and to better understand the epidemic and how to be able to support and assist a client who is in need of treatment. They understand the benefits of being in treatment and can better communicate that to their clients. Baseline Referrals along with Address & Contact Info are included for both Opioid Use & PolySub Use Providers. Copies of handouts are included as well as instructions for Narcotic Administration and Challenging MAT Myths as well as any handout found on the DUI MAT Project Portal. Admin Staff uses the information to reference on the Project Process and Case Management Framework Procedures. In the Binders, they also have signed client letters and Prescripts attached, file by Month. Under each month, they have separated those Prescreens done at Intake and Those conducted after Intake. These are entered into a log along with Client ID's to keep track of those clients who have been Prescreened. The log is referenced prior to clients coming in and their files are marked to show that the client has been pre-screened. The Counselor has stacks of DAST's and Handouts in their office should they believe that the client will benefit from another DAST during a Face-to-Face. Prescripts are entered each month in the Data Collection Portal for reporting directly to CADTF. The Binder is compared to Monthly Report and a Copy of the report is filed with each Month.

02


Have multiple treatment centers in your tool kit that you are in close contact with that will be able to offer what the client needs in terms of treatment.

Find Locations that cater to different clients, (example; undocumented, non-insured, homeless, unemployed...etc.)

04

Develop close contact with a point of interest at all treatment centers.



# Managing Project Deliverables

**Much of what we do, is seed planting and education on SUD. Many clients may be ready somewhere down the line.**

- Continue to monitor all handouts for reorder. Every client that enters our programs will need this information including all handouts and client letters to attach to prescreens. Be proactive and order more now rather than later.
- Order posters from handouts for all common areas and be ready for in-person services and a site visit.
- Reconcile monthly data and print report from portal after monthly reporting. This must match your MAT Prescreen binders.
- Implement prescreens and signed letters for all active clients, ongoing. Retakes are optional based on clinical overview. Reinstates and return from LOAs is another opportunity
- Train entire staff on objectives of grant and have regular MAT mtgs which allows MAT teams to brainstorm and review progress. Don't lose momentum!
- At regular MAT team meetings, review strategies for active clients and retakes. Develop plans for revisits on all assessments and ensure clients are referred to a member of the MAT team to meet with at-risk clients.



## Opportunities and Talking Points

### The MAT Project in the DUIP

- Over the years, many clients have requested additional services for treatment, we can assure clients that we recognize that many clients do not need this project, but it is available for those that do. Plants the seeds.
- Use the client introduction letter and informational handouts to ensure every client is given multiple opportunities to revisit this option for additional services, when indicated.
- Treat the client as the expert in their life! We do not diagnose or label, we facilitate the discovery process and support self efficacy by stating that only they can decide if they need support.
- When discussing the MAT Project with a client, explain that additional help with substance related issues is available, at any time. We can provide clients with an access point into treatment. Emphasize that it is not part of the DUIP order, is free, and is voluntary.


# Face to Face Sessions

## Title Nine 9856

- This is a critical time for using MI skills with OARs to foster self reflection and a review of their substance use history, by using the tools already in place Use the OARs to facilitate and navigate the entire substance use history
- DUIP assessment

**Review client letter with clients and tell them it is time for another round of prescreens.** Do not make it personal to the client. Take a casual approach, one that is informational only, as this continues seed planting without labeling or causing defensiveness. Clients often feel labeled as addicts or alcoholics and our goal is to be ready for guiding clients through a process they choose.



# Warm Handoffs

## Part of T-9 requires referrals to ancillary services as needed



- The baseline treatment referrals can be used by all DUIP clients, as well as MAT resources
- Identify a POC for each resource and contact them. Create a collaborative relationship that supports client care
- Send the handout we have provided, for collaboration with county, court and resources. This explains, who we are and what we do during the grant
- **Important Talking Point** – Provide resources without requests. Clients rarely “want” a resource. It is our responsibility to determine what may be beneficial and provide appropriate information. We should be the experts on resources in our community.

**Discuss this area at regular MAT Team mtgs. The entire staff should have all resources available. Share the POCs and know what each resources offers, hours, etc. Leaders provide the staff with the tools they need. This can be a regular conversation in our programs.**

# DUI MAT

### What is DUI MAT?

The DUI MAT Integration/Outreach Pilot Project supports the development and implementation of an identification and intervention pilot program for Opioid Use Disorder (OUD) and Polysubstance Use Disorder (SUD) to enable DUI program participants' access to treatment.

In addition, it supports the creation of connections to resources and referral options to medication-assisted and other treatment options in order to reduce opioid overdoses, opioid related traffic fatalities, and curb recidivism.

40 DUI Program Subcontractors have been selected to participate in the pilot project. DUI MAT services are now available in service locations throughout the state of California.

DUI MAT services include education, pre-screens and 2nd level assessments, treatment referrals, and counseling support. The data collected will help to determine the population of OUD and SUD persons who can be reached through interaction with the DUI treatment system.

The DUI MAT Project is one of over 30 projects to receive State Opioid Response II (SOR II) funding in support of the overall goals of the California MAT Expansion Project, made possible through a SAMHSA grant and the California Department of Health Care Services. The California Association of DUI Treatment Programs is the managing contractor of the DUI MAT Integration/Outreach Pilot Project.

Law enforcement continues to make advances towards detecting drug influence through field sobriety testing; however, the majority of DUI arrests and convictions continue to be based solely on the influence of alcohol. For this purpose, there is a significant gap for identifying inappropriate use or abuse of opioids amongst this offender population. Historically, with approximately 118,000 driving-under-the-influence (DUI) offenders enrolling in DUI programs annually, there is an opportunity for outreach and intervention amongst offenders with underlying opioid or polysubstance use disorder.

## Fentanyl

### What is fentanyl?

Fentanyl is a powerful synthetic opioid that is similar to morphine but is 50 to 100 times more potent.<sup>1,2</sup> It is a prescription drug that is also made and used illegally. Like morphine, it is a medicine that is typically used to treat patients with severe pain, especially after surgery.<sup>3</sup> It is also sometimes used to treat patients with chronic pain who are physically tolerant to other opioids.<sup>4</sup> Tolerance occurs when you need a higher and/or more frequent amount of a drug to get the desired effects.

In its prescription form, fentanyl is known by such names as Actiq®, Duragesic®, and Sublimaze®.<sup>4,5</sup> Street names for illegally used fentanyl include Apache, China Girl, China White, Dance Fever, Friend, Goodfellas, Jackpot, Murder 8, and Tango & Cash.

Synthetic opioids, including fentanyl, are now the most common drugs involved in drug overdose deaths in the United States. In 2017, 59.8 percent of opioid-related deaths involved fentanyl compared to 14.3 percent in 2010.


### What are Opioids?

Opioids are a class of drugs naturally found in the opium poppy plant. Some opioids are made from the plant directly, and others, like fentanyl, are made by scientists in labs using the same chemical structure (semi-synthetic or synthetic).

### How do people use fentanyl?

When prescribed by a doctor, fentanyl can be given as a shot, a patch that is put on a person's skin, or as lozenges that are sucked like cough drops.<sup>6</sup>

The illegally used fentanyl most often associated with recent overdoses is made in labs. This synthetic fentanyl is sold illegally as a powder, dropped onto blotter paper, put in eye droppers and nasal sprays, or made into pills that look like other prescription opioids.<sup>7</sup>
