

New York School of Ministry Courses

General Information for New York School of Ministry Courses

Our 20-hour courses offer folks a chance to learn about the Bible, Theology, Ethics, Religious History, and more, with excellent instructors, in a relaxed setting. They are webconferenced, so participants can connect with others across the Conference and in other states, from the comfort of their homes, via their computers. We are currently using the platform Zoom, which allows participants to see everyone in the virtual classroom and enhances discussion. Our courses can be taken for a grade or audited. Auditing is a great option for ministers who need continuing education and for lay people who love to learn but aren't interested in writing papers or taking tests.

No face to face meetings are required. Participants are expected to have webcams, which can be purchased for under \$30 at stores like Target. Contact Marjorie Purnine at mpurnine@uccny.org to schedule a test to see how webconferencing works.

Cost per 20-hour course:

NY Conference Participants: \$250; Audit: \$175; Repeat Course Audit: \$100

Participants outside the New York Conference: \$275; Audit: \$200 (plus the Distance Learning Support fee). Distance Learning Support fee: \$69 per 20-hour course or \$133 per semester.

Distance Learning requires technological support. For webconferenced courses, participants outside the New York Conference are welcome. The NY Conference provides that support for its participants through OCWM; we ask other UCC Conferences and participating denominations to provide that support for their participants (if such church support is unavailable, the distance learning support fee is the responsibility of the participant).

Spring 2017 Courses: American Church History and UCC Polity

In NYSOM's Christian Leadership Program, the essential elements of a UCC History, Theology, and Polity class (as defined by the Polity Teachers Network) are spread across various courses: American Church History, UCC Polity, Intro to Christian Theology, and Liturgy & Worship. American Church History is the pre-requisite for our UCC Polity course. There is no pre-requisite for American Church History (and, for those not in a certificate program, no expectation that UCC Polity will be taken). We advise those who need only a UCC History, Theology, and Polity course for authorization to take Rev. David Gaewski's UCC History, Theology, and Polity (offered Saturdays in January and June, via webconferencing) or an equivalent, free-standing course. Those who would like to be placed on Rev. United Church of Christ.

This course, required for the Christian Leadership Program, surveys the historical and current documents that illuminate the breadth of theology that informs the United Church of Christ. It provides an overview of the history of the UCC since 1957 and examines the covenantal structure of the church, the responsibilities and accountability of authorized ministers, worship, and vocation in the UCC.

12. The ability to articulate the UCC's commitment to being a united and uniting, multiracial and multicultural, open and affirming, accessible to all and just peace church.

6. The ability to articulate a theological understanding of authorized ministry, and to relate it to the practice of ministry.
12. The ability to appreciate, practice, and pass on traditions of faith while interpreting them in light of the context of a diverse and changing world.
