

### Bills we're watching

#### [HB 1094](#)

Revises certain provisions regarding the municipal zoning and appeals process to be less burdensome; is companion legislation to SB 157 last year that updated the county zoning and appeals process.

#### [HB 1109](#)

Modifies requirements and restrictions related to certain alcoholic beverages. This would legalize homebrewing in the state of SD.

#### [HB 1133](#)

Reduces fees for annual state park licenses for South Dakota residents. Reduces fee for state park annual passes by 25% for resident of SD.

#### [HB 1203](#)

Authorizes banks to engage in business with industrial hemp or marijuana licensees and associated persons.

#### [HB 1211](#)

Authorizes, regulates, and taxes wagering on sporting events across the state but limited to establishments that hold a full beverage liquor license. This bill does not allow sports bets at lottery outlets or mobile devices.

#### [HB 1239](#)

Makes an appropriation to build a traumatic brain injury center in the Black Hills.

#### [HB 1253](#)

Makes an appropriation for developing the Mickelson Trail.

#### [HB 1259](#)

Creates the rural access infrastructure fund.

#### [HB 1263](#)

Provides price transparency for health care costs.

#### [HB 1021](#)

Makes an appropriation to reimburse certain health care professionals who have complied with the requirements for certain health care recruitment assistance program

#### [HB 1159](#)

Prohibits interference with the right to bodily integrity in contagious disease control.

#### [HB 1246](#)

Imposes a tax on the gross receipts of ambulatory surgery centers and surgical specialty hospitals and provides a penalty for a violation thereof.

### [SB 137](#)

Provides for the reimbursement of lost revenue for businesses forcibly closed by a governmental entity.

### [SB 30](#)

Extends the issuance period for commercial learner's permits.

### [SB 44](#)

Authorizes, regulates, and taxes wagering on sporting events within the city limits of Deadwood.

### [SB 54](#)

Make an appropriation to build a bison visitors center in Custer State Park.

### [SB 92](#)

Require that certain proposed rules include an affordable housing impact statement.
