SEC Commissioner Mark T. Uyeda updated the audience on recent SEC rulings, and other current undertakings within the commission.

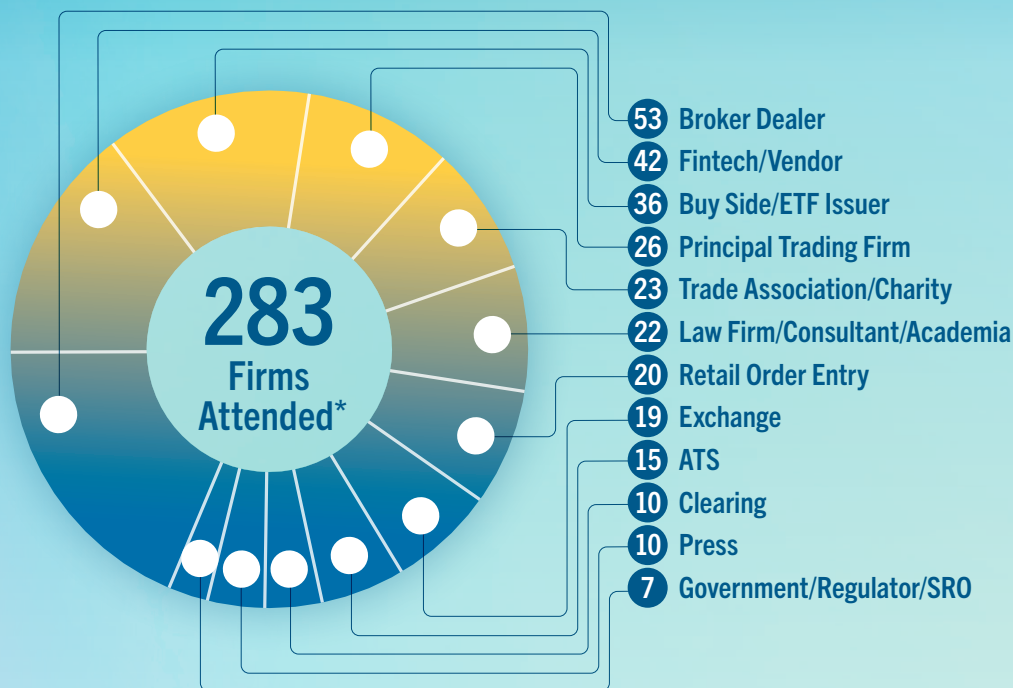
