

# 2019 BOHM THEATRE OSCAR PREDICTION CONTEST



## CONTEST DESCRIPTION

As a “*FUNraising*” event, The Bohm Theatre annually hosts an Oscar Prediction Contest to coincide with the Academy Award Season honoring excellence in motion picture production. **Funds from the Oscar Contest will go toward helping support operations at the Bohm Theatre during the winter weeks from mid January through February when utilities and overhead costs can be higher.**

*If you're a film lover or you just want to support the Bohm Theatre and get some “inside” information on upcoming events scheduled at the Bohm for 2019, then this contest is for YOU!*

The Bohm Theatre Oscar Contest (the “Contest”) is a competition in which participants compete to guess the 2019 Academy Award winners in **ALL 24** categories of nominations. The participant with the most correct guesses will be deemed the Potential Winner of the 1st Place prize. In the event of a tie for most correct guesses, the Potential Winner will be chosen by random drawing from among those tied entries. Prizes will also be awarded for 2nd and 3rd Place entries. Potential Winners for 2nd and 3rd place will be the participants with the next-highest number of correct guesses, or, in the event of a tie, will be chosen by random drawing from among those tied entries.

## OFFICIAL RULES

- Contestants must provide their name and email address contact information (phone number optional).
- Contestants may only check one (1) nominee per category.
- Any categories left blank or with multiple nominees checked will be counted as incorrect and the ballot will be disqualified.
- Bohm Membership is not required for entry or participation.
- You can purchase more than one Ballot BUT only One Prize Per Household or Business.
- Individuals must be 18 years of age or older to participate.
- Entries must be received **NO LATER THAN SATURDAY, FEBRUARY 23, 2019** - prior to the airing of this years 2019 Academy Awards Ceremony scheduled for Sunday, February 24, 2019.
- Entries must be submitted in person or via postal mail to the Bohm Theatre, 201 S. Superior St, Albion, MI 49224.
- Prizes are determined by the number of correct answers.

Potential Winners are not entitled to any difference between actual retail value ("ARV") of a prize and stated ARV, and any difference between stated ARV and actual value of the prize will not be awarded. No substitution, transfer or cash redemption of a prize is permitted, provided however that Sponsor or Promotional Partner reserves the right to substitute a prize with another prize of equal or greater value should the advertised prize become unavailable for any reason. Potential Winners are solely responsible for all federal, state and local taxes on prize and other unspecified expenses related to prize. ## ELIGIBILITY

**The Contest is open to anyone who is at least 18 years old at the start of the Contest on January 22, 2019.**

Employees, officers and directors of Bohm Theatre, and their immediate family members (defined as spouse, mother, father, sisters, brothers, sons, daughters, uncles, aunts, nephews, nieces, grandparents and in-laws, regardless of where they live) and those living in their household (whether or not related), and each person or entity connected with the production or administration of the Contest, and each parent company, affiliate, subsidiary, agent and representative of any aforementioned entity are not eligible.

As a condition of accepting a prize, each Potential Winner MAY be required to execute a declaration of eligibility and liability release, attesting that the Potential Winner has complied with all rules and releasing Sponsor and Promotional Partner from all liability for damages or personal injury that may occur in connection with the Potential Winner's use or acceptance of the prize or any activities related to the prize.

## CONTEST PERIOD

**The Contest begins on Tuesday, January 22, 2019** when the 2019 Academy Award Nominations are ANNOUNCED and ends on Sunday, February 24, 2019 when the Academy Awards are televised Live on ABC.

**All entries must be submitted by the Deadline on Saturday, February 23, 2019.**

## HOW TO ENTER

Any eligible individual wishing to compete in the Contest ("Entrants") must enter by purchasing and completing and submitting predictions for the 2019 Academy Awards. Entrants will be required to submit: name, city, state, phone number, email address and date of birth. Entrants may submit one entry during the Contest Period. Entries must be received no later than 5 PM EST on Saturday, February 23, 2019. By entering, Entrants accept and agree to be bound by these Official Rules, including the decisions of the Bohm Theatre Management, which are final and binding in all respects. Any individual who attempts to enter, or in the sole discretion of Sponsor is suspected of entering, more than once, by any means, including but not limited to submitting multiple entries, will be disqualified from the Contest.

Sponsor is not responsible for late, delayed, incomplete or corrupted entries. Entries generated by a script, macro or other automated means will be disqualified. In the event a dispute regarding the identity of the individual who submitted an entry cannot be resolved to Sponsor's satisfaction, the affected entry will be deemed ineligible.

## ODDS

## NOTIFICATION

**The Winners will be notified no later than March 1, 2019, via email and announced on our website.** A Potential Winner has five (5) days from sending of notification to claim his/her prize by responding via email or an alternate Potential Winner will be selected. An alternate Potential Winner will be selected in the event of noncompliance with these Official Rules, or if a Potential Winner cannot be contacted, provides incorrect e-mail or mailing address, is ineligible, fails to claim a prize or if the prize notification is returned as undeliverable.

Potential Winners will also be sent and must sign an affidavit of eligibility / liability / publicity release ("Release"). Except where prohibited by law, by entering the Contest Entrants who become Potential Winners agree that Sponsor may use their name and picture for marketing purposes. ## DISPUTES

Except where prohibited, Entrant agrees that any and all disputes, claims and causes of action arising out of, or connected with, the Contest or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the appropriate court located in Michigan. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, Entrant's rights and obligations, or the rights and obligations of the Sponsor in connection with the Contest, shall be governed by, and construed in accordance with, the laws of the State of Michigan, without giving effect to any choice of law or conflict of law rules (whether of the State of Michigan or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Michigan.
