EARNED INCOME TAX CREDIT (EITC) is a refundable tax credit for low-to-moderate-income working individuals and couples, particularly those with children.

EITC is for workers whose income did not exceed the following limits in 2020:

- \$50,594 (\$57,414 married filing jointly) with three or more qualifying children
- \$47,440 (\$53,865 married filing jointly) with two qualifying children
- \$41,756 (\$48,108 married filing jointly) with one qualifying child
- \$15,828 (\$21,920 married filing jointly) with no qualifying children

To receive the EITC you must file a tax return, even if you do not owe any tax or are not required to file. If you qualify for EITC, you may also be able to claim Child Tax Credits worth up to \$1400. More at: http://www.irs.gov/EITC or contact a VITA site listed on reverse.

FREE TAX PREPARATION FOR QUALIFYING TAXPAYERS

Call these organizations to confirm when free tax help is being offered, if you qualify, what items you need to bring, and to schedule an appointment.

Volunteer Income Tax Assistance (VITA) offers free tax help to people who generally make \$56,000 or less, persons with disabilities, the elderly, and limited English speaking taxpayers who need assistance in preparing their own tax returns. IRS-certified volunteers provide free basic income tax return preparation with electronic filing to qualified individuals. Due to the COVID-19 pandemic, there are no face-to-face appointments so tax information will need to be dropped off at the site. BE SURE TO BRING THE FOLLOWING TO APPOINTMENTS:

- State-issued Photo ID, W-2 forms, and Social Security cards for those included on your tax return
- IRS correspondence in 2020 and any appropriate IRS forms, such as 1098 and 1099 forms, if any
- If you had child care expenses, bring provider's social security number (or EIN), address, and proof of payment.
- If married filing jointly, both parties must be present in order to process the tax return.
- If you want direct deposit of refund, bring bank account and routing numbers with you.



2020 Tax Year Information Recovery Rebate Credit and Unemployment

Did you receive either the 1st or 2nd Economic Impact Payment (stimulus) Payment?

To check, go to https://www.irs.gov/coronavirus/get-my-payment
Use Get My Payment to:

- Confirm your stimulus payment.
- Confirm your payment type: direct deposit or mail.

Data is updated once per day overnight, so there's no need to check back more than once per day.

Please do not call the IRS about the payment; our phone assistors do not have additional information beyond what's available on IRS.gov and in the Get My Payment application.

If you did not receive an Economic Impact Payment (stimulus) check in 2020:

"Eligible individuals who did not receive the full amounts of both Economic Impact Payments may claim the Recovery Rebate Credit on their 2020 Form 1040 or 1040-SR. To determine whether you are an eligible individual, or the amount of your Recovery Rebate Credit, complete the Recovery Rebate Credit Worksheet in the Instructions for Form 1040 and Form 1040-SR. If eligible, you can claim the Recovery Rebate Credit when you file your 2020 tax return (Form 1040 or Form 1040-SR) electronically using tax software or on paper. The 2020 tax return instructions include a worksheet you can use to figure the amount of any Recovery Rebate Credit for which you are eligible. The worksheet requires you to know the amounts of your Economic Impact Payments. You must file Form 1040 or Form 1040-SR to claim the Recovery Rebate Credit even if you are normally not required to file a tax return."

If you received unemployment:

"Unemployment benefits must be reported on your federal tax return. A record number of Americans are applying for unemployment compensation due to the COVID-19 Outbreak. If you received unemployment benefits, as well as the additional \$600 per week in coronavirus relief any time during the year, your tax return may be affected." https://www.irs.gov/pub/irs-pdf/p5444.pdf

To report unemployment compensation on your taxes, "you should receive a Form 1099-G, Certain Government Payments, showing the amount of unemployment compensation paid to you during the year." Report the correct amounts in the correct boxes.
