Eligibility for Congregate or Home-Delivered Meals

Meal options exist for older Ohioans who have limited mobility, lack transportation, or are homebound through the Older Americans Act. Title III is a section of the Older Americans Act that supports selected community-based and in-house services like nutrition. Home-delivered meals, popularly known as Meals on Wheels, provide nutritious hot meals right to the door. Congregate meal sites are available in all nine counties that provide both nutritious meals and social interaction. These options are also available to adult Ohioans of any age who are living with a disability and have the same limitations.

I. Basic eligibility for the Title III Congregate Meal is - any person sixty years of age or older:

Additional eligible persons:

1. The spouse of the person who is 60 years or older if the spouse accompanies that consumer to the congregate dining location.
2. A volunteer who provides volunteer services at the congregate dining location during the mealtime.
3. A person with disabilities who resides in the home of the person who is 60 years or older if the person with disabilities accompanies that person to the congregate dining location.
4. A person with disabilities who resides in a non-institutional residential building, but only if the building's residents are primarily 60 years of age or older and the meal is offered through a congregate dining location located in the person's building.

II. Eligibility for the Title 3 Home-delivered Meal:

1. A person who is 60 years or older and meets the following requirements:
 - a. unable to prepare his or her own meals,
 - b. unable to consume meals at a congregate dining location due to physical or emotional difficulties, and
 - c. lacking another meal support service in the home or community.

Additional eligible persons:

1. The spouse of the eligible 60 years or older person.
2. A volunteer who provides volunteer services to the 60 years or older eligible person(s).
3. A person with disabilities who resides in the home of the 60 years or older eligible person(s).
