## Cannabis Confusion

I would like to encourage the legislative committee working on creating logical and enforceable rules to keep up the good work and take the time needed to put together a logical and comprehensive piece of legislation that can be passed.

By the time this newsletter reaches you, we won't

know whether the legislators met Thursday's deadline to approve clarifying legislation. If that failed to happen, the proposed legislation that approved by citizen initiative will go into effect. By all reports and by my own read, that legislation was hastily and poorly written and does not protect employers and many others, including minors.

There is a discussion that the legislature could approve an extension of the moratorium till May 1. I believe that this makes good sense and will provide a bit more time to solidify good rules.

The Maine State Chamber reports that a collaboration of organizations have come together and hired legal representation from Peter Lowe of Brann & Isaacson Law firm in Lewiston to create a toll-free phone line and a website especially designed for employers to call or ask questions on line, at no cost, regarding marijuana issues as it relates to their business.

The Biddeford+Saco Chamber will continue to follow this issue and provide input at the State Chamber board of directors, as well as be a resource to local legislators such as Senator Susan Deschambault who serves on the marijuana committee.

The Biddeford+Saco Chamber will keep employers informed as the marijuana Help Line and website get launched. This is a serious issue that demands our attention.
