Learning Objective:

Recognize national affordable housing programs and policy changes leading up to current day

- II. Affordable Housing in Colorado – Getting to Know the Players and Funding Sources

Learning Objectives:

1. Gain increased awareness of the state government involvement in increasing safe and decent affordable housing.
2. Review the statewide organizations involved in grant making and funding allocations to expand affordable housing
3. Explore the processes used in developing community based housing needs assessments required in HUD's five year plans and applications for funding

III. Serving as a housing authority commissioner

Learning Objectives:

2. Establish personal learning goals toward continuing to develop as an effective advocate engaged in the expansion of affordable housing

IV. The Functions of a Local Housing Authority Board

Learning Objectives:

1. Recognize the legal and fiduciary responsibilities of Housing Authority Boards
2. Explain the difference between policy and administrative functions
3. Define the employer/employee relationship between the Executive Director and Board
4. Describe the decision making processes of an effective governing board
5. Describe effective methods that can be used to reach group consensus
6. Define the processes involved in developing effective relationships with local and national stakeholders engaged in various aspects of affordable housing
7. Recognize the power of the board comes from speaking with ONE VOICE and not from the opinions of individual board members

Participant Preparation

Course participants will be asked to make short presentations (10 minute max) describing their local housing authorities (LHA). Presentations should include reference to the mission of the LHA, as well as brief descriptions of the customers and communities served. Please note multiple commissioners attending from a single LHA will make team presentations.
