Continued - A Message From The President

For police officers, dispatchers, firefighters and all of our medical professionals, working remotely is not an option. We have been tasked with working the front lines of this battle, fighting the COVID-19 virus from all angles. The men and women who work for varying law enforcement agencies across this great Commonwealth have been answering the call, without question or regard for their own safety. The EMS workers have tirelessly and fearlessly been going into homes and transporting sick patients to area hospitals where the nurses, doctors and other medical professionals have been doing their best to treat the overwhelming number of COVID-19 patients brought to them on a daily, sometimes hourly basis, also without question and without regard for their own safety.

The one concern that we all share that we are now compelled to ask after watching our brothers and sisters fall victim to this virus is to be PROTECTED. Protected from this invisible enemy we are doing our best to take on. Unlike most of the situations that we deal with on a daily basis with this enemy, we are unable to establish a search pattern. We cannot use overwhelming force and we cannot defend ourselves with the tools on our belts. There is no level of tactic that we can employ that will be effective in defeating this. So we have to adapt and overcome, and ask that our leaders give us NEW TOOLS. In this battle, we need PERSONAL PROTECTIVE EQUIPMENT. We need proper masks, eye protection, gloves and effective disinfectants and sanitizers. We ask for these things to not only protect ourselves, but also to protect the members of the community who we unwittingly come into contact with on a daily basis. We have a duty to protect THEM as well. We also have a duty to protect our own families from the exposures we are subjected to daily without the proper equipment.

I have spoken with dozens of MassCOP's Local presidents in an effort to keep apprised of how cities and towns are handling the various intricacies surrounding the fight against this virus. I have been in constant communication with the members of the Executive Board who represent each and every one of you. We are working with our attorneys and legislators to ensure that all of the police officers in this State are afforded all of the protections that they are entitled to, including proper treatment for COVID-19 positive officers, as well as appropriate PAID quarantine periods for their co-workers. This has proven to be more of a challenge in some areas.

I have received reports of varying levels of cooperation in both regards. Some departments have been very proactive and have agreed from the onset to follow all of the CDC recommendations and guidelines, and have without hesitation placed officers who test positive onto 111F status, and those in quarantine on paid administrative leave. I have seen proactive measures taken where local unions and their administrators have worked together to set up creative scheduling to limit the cross contamination of shifts. In some departments, officers and dispatchers are rotating between working and being on call for two-week intervals to again limit exposure and maintain staffing levels. I have heard of departments where a shortage in safety equipment is not an issue, and other departments who are detrimentally struggling. It really is a different chapter of the same story as you move from one agency to another.

Regrettably, there are some Chief's and Administrators whose behavior is simply abhorrent. Clearly there is still some margin of denial regarding just how serious this issue is. It goes beyond the virus itself and expands into the far-reaching web of disaster being spun by these so-called "leaders". Leaders who refuse to take care of their first responders who are being exposed and are getting sick and in some cases are dying. Refusing to place police officers testing positive for COVID-19 on 111F status and/or refusing to pay officers who are in quarantine is outrageous behavior that simply cannot be tolerated. Refusing to quarantine exposed officers until they are "symptomatic" should be criminal. There was one Chief who actually demanded his officers continue to follow the departmental policy on "park and talks", requiring officers to park their cruisers and "talk to the people" in direct conflict with Governor Baker and President Trump's order for distance. This Chief believes his asinine mandate is more important than the safety of his officers and by default, the very community he's sworn to protect. You really can't make this up.

New Legislation - COVID-19

The Massachusetts Coalition of Police Legislative Team has been working non-stop during the Covid-19 Crisis to bring first responders the protections that they deserve. Police officers have been at the front lines of this crisis since its inception. We have been working with the legislature on bills to create 111F presumptions as well as attempting to increase wages for police officers who have been on the front line. In addition, we have been seeking reimbursement for cities and towns for overtime relating to the crisis.

The following is a list of the bills that we have been most focused on:

SB-2602 Senator Moore - An Act Relative to Emergency Hazard Health Duty - Referred to Joint Committee on Public Safety and Homeland Security.

- Mass Cop is a Co-Sponsor Supporter of this bill. (This bill has an Emergency Preamble on it.)
- April 6, 2020: MassCOP and Sandulli Grace submitted favorable written testimony.
- April 21, 2020: Bill held in abeyance at the Joint Committee on Public Safety until May 1st when it will be forwarded to the House and Ways Committee.

HB-4611 Representative Arciero - An Act Relative to Emergency Hazard Health Duty - Referred to Joint Committee on Public Safety and Homeland Security.

- Mass Cop has signed on as a Co-Sponsor of this bill. (This Bill has an Emergency Preamble on it.)
- April 6, 2020: MassCOP and Sandulli Grace submitted favorable written testimony.
- April 21, 2020: Bill held in abeyance at the Joint Committee on Public Safety until May 1st when it will be forwarded to the House and Ways Committee.

HB-4613 Representative Chan - An Act Relative to State Employees Performing Core Functions - Referred to Joint Committee on Public Service.

- Mass Cop has signed on as a Co-Sponsor of this bill.
- No hearing date posted.

SD-2886 Senator Moore - An Act Providing Emergency Assistance for Municipal Public Safety Overtime - Referred to Joint Committee on Rules.

- Mass Cop is a Supporter of this bill. (No bill number assigned.)
- No hearing date posted.

HD-4977 Representative Kane - An Act Providing Emergency Assistance for Municipal Public Safety Overtime - Referred to Joint Committee on Public Safety and Homeland Security.

- Mass Cop is a signed Co-Sponsor of this bill. (No bill number assigned.)
- No hearing date posted.
