MINUTES OF THE ANNUAL MEETING OF THE PARISH

Christ Church Parish Hall - Sunday, January 26, 2020

WELCOME AND OPENING PRAYER

Rector Fr. Tom Purdy called the business session of the Christ Church Frederica annual meeting to order at 6:40 pm following the welcome, opening prayer and announcement of Youth baking contest winners.

APPOINTMENT OF SECRETARY

Fr. Purdy appointed Susan Shipman as Acting Secretary in the absence of the Secretary of the Vestry.

APPROVAL OF THE 2019 ANNUAL MEETING MINUTES

The reading of the minutes was waived. The minutes of the 2019 Annual Parish Meeting were approved unanimously following a motion and a second.

ROOTED, GROWING, BUILDING CAMPAIGN

Fr. Purdy spoke about the three parts to the Rooted, Growing, and Building Campaign: Annual Giving, Capital Giving, and Legacy Giving. An educational session relating to the Dodge Society is planned for March 15, 2020. Ways to remember Christ Church in perpetuity will be discussed. (Secretary's note: COVID restrictions caused the cancellation of the seminar).

The campaign is 40% toward its goal. As the campaign progresses, the Vestry plans to address deferred maintenance on the Christ Church campus physical plant. The various projects which Father Tom enumerated for parishioners are estimated to be less than \$100,000. The Vestry has set aside \$100,000 for those projects. The road relocation is not likely to be addressed until 2021. Letters featuring the Capital Campaign, the Dodge Society, and Pledge cards should be received by parishioners in the coming weeks. He asked that Pledges be submitted by mid-April. There were no questions on this report.

PRESENTATION OF REPORTS

JUNIOR WARDEN'S REPORT

Junior Warden Alice Barlow thanked and commended Glenn Queener and Harry Branch for their stellar service in the accomplishment of many projects. Mrs. Barlow provided an update on building improvements made to all church properties, including replacement of HVAC units, Dodge Home asbestos removal, and contracting for painting which will soon start. Development of and implementation of an emergency preparedness plan was accomplished. Father Tom commended and thanked Alice and Fred Barlow.

SENIOR WARDEN'S REPORT

Senior Warden Wallace Harrell reviewed the many and varied aspects of parish life and the work Christ Church is doing internally and externally. He highlighted parish life activities, the parish's mission and outreach work, and the good work of the ECW. He saluted the guilds and Christian education through Kidurgy, Sunday School, and formation. Mr. Harrell saluted the staff contributions to these activities, plus worship and ministry and pastoral care, among others. He thanked the vestry, clergy and parishioners for their support during his tenure.

TREASURER'S REPORT

Treasurer Bonney Shuman discussed the financial reports and presented the budget for the coming year. The Church finished 2019 with a \$4,000 surplus. The Vestry drew 5% on investment accounts. The goal for the coming year (2020) is a 4% draw on investment accounts. Mrs. Shuman commended Glenn and Stan, noting they are outstanding resources to the church's financial management. She presented the 2020 budget approved by the Vestry, and noted that 2020 pledges are strong. Father Tom encouraged everyone to be generous, so as to sustain our many important ministries. Mrs. Shuman expressed gratitude for the work of the Finance Committee chaired by Kim Chitty; David Blatchford (who heads up the Tellers Committee), and Patrick Parker (who heads up the Investment Committee). Father Tom commended and expressed gratitude for Mrs. Shuman's outstanding work as Christ Church Treasurer.

REPORT FROM HEAD TELLER

Fr. Purdy recognized Head Teller David Blatchford and thanked all the tellers for their work on the election. Mr. Blatchford announced that the following parishioners had been elected: Ed Turner, Catherine Holt, Beth Smith, and Susan Garrett. Should any vestry person be unable to serve during the coming year, Sarah Kreimborg would fill that seat, as she was the nominee receiving the next highest number of votes, making her the first alternate. Father Tom thanked all candidates who were on the ballot.

RECTOR'S REPORT

Fr. Purdy Tom's report detailed the many ways Christ Church is a phenomenal church to do ministry. He saluted the gifts of leadership of the four Vestry members rolling off: Wallace Harrell, John Killgallon, Kelly Galland, and Alice Barlow. He followed with shout-outs for all our clergy and staff: Mother Ashton, Mother Katie, Mother Becky, Glenn, Kathleen, George, Harry, Julie, and Stan; for their hard work across the year. He noted this was our strongest year we've had with staff --- no turnovers and great stability. He also introduced Amy Certain, part-time staff for the campaign. Father Tom thanked the Vestry and other parish volunteers for their service.

Father Tom discussed the church's 2020 priorities: the Rooted. Growing. Building. Campaign; children, youth, and families who are the church of not only today but tomorrow; our seniors and shutins; supporting the vulnerable in our community through our vibrant mission and outreach; worship and formation; and the hallmark of our parish, which is meeting God and forming disciples.

Father Tom outlined his plans for his summer sabbatical, which is intended to be restorative for the rector and the parish. It is fully funded through the Lilly Family Foundation. He laid out the route for his family's R/V trip around this great country, culminating in a week at Canterbury Cathedral. He will provide us periodic snapshots of his progress through Guest Ramblings.

Rector's Report

2020 was an unusual year. The pandemic affected everything we did for most of the year, so it's not surprising that it will affect my annual report to the parish! Typically, I go back and highlight a year of ministry that includes events and gatherings of all sorts, although so many of those didn't take place. There is much to celebrate, nonetheless.

The most exciting thing that happened this past year was the launch of our Capital Campaign in January. The fruit of years of work to consider how we could best address the needs of the parish, particularly around parking and safe access, the Rooted. Growing. Building. campaign invited us all to consider Christ Church and her future with a long lens. Aware of the length and breadth of our history, the Vestry wanted to make sure we weren't being short-sighted when we crafted our Master Plan. Instead, we looked out 100 years and considered what we might need in order to continue to flourish in ministry. Our campaign represented the first phase of fulfilling that vision.

We had a tremendous early response to the campaign and were able to secure nearly half of our fundraising goal before the pandemic led us to suspend our campaign solicitation until 2021. We moved ahead on the portion of the project that would move Frederica Road, and although there were some unexpected developments, the Vestry responded in a faithful and decisive way to ensure that the project would continue and not be put off for years. By the end of 2020, the road design and engineering were nearly complete, and we expect construction will begin in the early part of the second quarter of 2021. We are grateful for Rip Graham, our Building Committee Chairman for all his hard work this year.

We didn't have time for much else before the pandemic changed our parish life dramatically. Only ten weeks into the year, I made the decision (in consultation with the Vestry) to suspend in-person activities and worship as the news about the pandemic and its dangers became clear. We were the first parish on the Island and in the Diocese of Georgia to do so, but our brother and sister congregations began to follow suit within a day. By the weekend, the Diocese of Georgia suspended in-person worship and in-person gatherings for all parishes.

The early part of the pandemic was an anxious time for all of us. We did our best to reach out to every family in the parish in those early weeks, to make sure everyone was doing ok and to offer assistance to those who might need it. The Vestry and Staff worked to secure short-term financial arrangements to counter the initial loss of regular pledge income that gave us great concern (income stabilized as time went on). We shifted to virtual worship and gatherings almost overnight, and quickly learned how to improve our offerings. We worked to train parishioners on how to use technology to access these new offerings. It's fair to say that overall, we learned as we went.

In the summer months, the Vestry and I formed a task force to examine what reopening for in-person worship and activities could look like and how we might achieve that goal as we came down off of a caseload spike in Glynn County. We continued to find ways to do pastoral care through phone calls and distanced porch visits. We discovered that we could distribute communion to people by delivering it to their homes. Eventually, we were given permission to add drive-through communion, which, while strange, was also comforting to almost everyone who participated. As the Diocesan guidelines began to shift and it became clear that we could mitigate risk in various ways we installed a tent in the front yard of the historic Church and began offering in-person worship in the church yard in October. It wasn't until Christmas that we finally had to deal with steady rain during worship; not bad for having been in the tent for two months! The tent allowed not only worship, but different kinds of parish gatherings, like our youth group. Even our docents were able to utilize

the tents to greet visitors and keep those ECW cookbook sales going!

The Pandemic brought out the best in our parish. Backpack Buddies exploded (in a good way!), distributing about 15,000 bags of food to Glynn County kids from the time schools were suspended, until they reopened in the fall. That effort was only possible under the leadership of Susan Shipman, the countless volunteers who came in to work in small groups, and all those who donated money to purchase the food. We also saw a tremendous response to our Pandemic Fund drive, which culminated in the creation of nearly 30,000 cloth masks for local schools to use with their student populations. The mask donation was greatly appreciated, and the outpouring of support from donors and iron-ers was remarkable. There were many other small things we could note that we did for one another as a result of the pandemic, too. As I would have expected, Christ Church stepped up and took care of its neighbors in meaningful ways, work that continues.

I am, of course, biased, but I am so pleased with our staff and our leadership during this pandemic. We have had to make tough decisions and find new ways of doing things that were considered routine not that long ago. We haven't been perfect, but overall, we've seen wonderful outcomes and gotten good feedback throughout the pandemic. I am particularly proud of our worship. I'll single out staff later, but just know that it is not easy to do what we do with virtual worship, and it's through the many efforts of our staff that we have had such a viable option for connecting to our faith and our liturgical community, when meeting in person wasn't prudent. We were already used to basic live stream worship before the pandemic, but once we realized it was our "new normal," we invested in upgrading technology and devoting the time it takes to offer high-quality online worship. Worship is one of the primary and unique things the Church facilitates (as opposed to what another organization or non-profit may do), and we should celebrate our online presence; it is on par with our beautiful spaces and treasured grounds in the sense that it sets us apart from most other congregations.

Our Vestry has been phenomenal this year. None of us has lived through or led through a pandemic before, yet our Vestry has taken challenges and opportunities in stride. As a group, we were able to remain non-anxious in the face of great uncertainty, while finding ways to support and encourage ministry to continue. We wrestled with tough matters like what to do with our campaign and how to manage budgets. The Vestry also had to consider public health issues and contemplate the safety of our parishioners and staff. Through it all they have been committed and faithful, and we could not have succeeded this year without their steady support and wisdom. Chief among the Vestry's leaders are our two wardens, Beth Smith and David Blatchford. The three of us had many conversations about new problems this year and I am grateful for their leadership. I am also grateful for our Treasurer, Bonney Shuman, and our Finance Committee, chaired by Kim Chitty. We navigated some tricky financial waters this year, quite successfully, and all are to be commended.

For much of the year our Altar and Flower Guilds didn't have as much to do as they might have in a typical year, yet we always had what we needed, including arrangements in the Church for streamed services. During the pandemic, Nancy Zell passed the Altar Guild Chair baton to Sherry Bowen. I appreciate them both and all that they do to serve alongside the Guild in this important ministry. The Flower Guild, under Anna Belle McCaskill's guidance also managed to continue to beatify our spaces for worship, including stunning Easter arrangements that adorned the Rectory Family Room for what I assume will be the strangest Easter in my life. The Guild also managed to make our tent look incredible for worship on Christmas Eve.

Our office volunteers are always an integral part of our day-to-day life. We missed having them with us for most of the year, although we did see some of them return to shorter shifts as parish

life opened back up a bit this fall; thank you all for that important ministry. Chris Franklin is also a gift to us, as she serves as our parish registrar. Our parish is constantly adding and saying goodbye to members, and Chris keeps all the transfers and updates to the system up to date. It's a quiet, unseen ministry, but an important one for which I am also thankful. There are a host of persons who have also given their time and energy and backs to make sure that outdoor worship can happen each week, setting up and taking down on Sundays and as needed; we couldn't do it without them!

There are a host of other volunteers who make parish life possible. All of them served faithfully prior to the pandemic, while some have continued to function in new or amended ways during the pandemic. Thank you to all who give back to the church through their time and energy spent on parish ministry. In no particular order, I want to especially thank ministry leaders including The Rev. Dr. Bob Brown, Randy Siegel, and Godfrey Draviam (Adult Ed. and Formation Leaders), Susan Garrett (Docents), Christine Plank (Coffee Hour), Donna Purdy (Angel Guild), Elise Meeks (Newcomers), Susan Imhoff (Ushers), David Blatchford (Tellers), Sarah and Tony Kreimborg (Mission), Vicki Ream and Rees Sumerford (Wesley Garden Trustees). Taylor Lenon has come on board as a volunteer technology support person, which we desperately needed. We have also been ably and faithfully served this year by our Chancellor, Rees Sumerford, who advises the Vestry on legal matters, and by Gordon Zeese, who has served as Secretary of the Vestry this year.

Our clergy staff has done wonderful ministry despite the challenges 2020 presented. Mother Ashton continues to shepherd our pastoral care ministry with the help of a core of volunteers. The standout ministry this year is our flower ministry, which sends altar flowers to parishioners for various reasons. Although I didn't take sabbatical this past summer, I was prepared to, knowing that Ashton would be a capable leader in my absence, for which I am grateful. Mother Katie faced a big challenge when we couldn't meet in person, but has managed weekly Kidurgy videos and by Advent, a weekly Family Service in the tent. Our families have very much appreciated her efforts, as have I. Mother Becky has been a tremendous support for formation and pastoral care. All three priests on my clergy team have handled online worship and distanced ministry extremely well!

Kathleen Turner certainly rose to the occasion when our music ministry was affected by the pandemic; she coordinates recordings for each Sunday's music, assists the Diocese from time to time with their music, and managed to get ensemble music going again through Joyful Noise and Bell Choir offerings. Our worship couldn't be as successful as it has been without her gifts. I am grateful for all our musicians, and especially for our section leaders who work on our hymns and anthems each week. Glenn Queener has been the right person for the job over and over again in 2020, helping us navigate the pandemic on the operations side. He helped us apply for, receive, and then have forgiven, our PPP loan offered by the legislation Congress passed. He's also been my partner in our technology ministry. Our ability to produce live worship and maximize our technology for things like Evening Prayer each day are possible because of Glenn's hard work and his ability to find solutions to our problems. He also made sure that all our worship and activities met Diocesan and public health guidelines, which has been essential to our functioning during the pandemic.

Harry has continued to be a servant minister to all of us in his role as Sexton and Cemetery Superintendent. He watches over properties that aren't used the same way they used to be and require monitoring, and he has taken on a yeoman's work with tent worship. I don't know how he does it all, but I'm so grateful that he does. Julie Hancock's communication ministry has been vital to us this year, too. We added a weekly mailing for those who couldn't be with us in person and don't receive emails. There was a need to communicate many things clearly this year, and Julie has done a wonderful job, even while undergoing treatment for cancer. Stan Kyker has continued to serve as a capable and organized Financial Administrator, and I was sad to accept his resignation at the end of 2020. He will be retiring (well-deserved) in early 2021 and it will not be easy to replace him. Prior to the pandemic, we were also grateful for Amy Certain and her work as our Capital Campaign Administrative Assistant, as she worked on events, mailings, and records for the campaign. There were so many details that we needed someone to help us and she certainly did!

My ministry outside Christ Church's walls continued in 2020. One change that involved some additional time and energy was my role with Hospice of the Golden Isles. I assumed the role of President and Chairman of the Board of Directors at the start of the year. It was an active year for this wonderful organization, as we managed to work out an affiliation deal to begin a regional non-profit network, and also found ourselves searching for a new CEO/Executive Director. It's an honor to serve such an important organization on behalf of Christ Church. A spinoff of that work is serving as Vice President of Aliva Care of Georgia, a new non-profit hospice affiliation network that seeks to strengthen non-profit hospices in Georgia through affiliation. I continue to serve as Vice President of the School Council at Burroughs Molette Elementary. Additionally, I've been one of a number of Glynn County clergy working on building relationships across a diverse group of clergy and specifically addressing racial harmony in our community. I continued my work with the Diocese of Georgia as Chair of the Commission on Ministry. It is important that all clergy serve the wider "parish" beyond our walls; it's a part of our ordination and the expectation of the bishop. I am always aware that I represent Christ Church and am grateful that I can use my time and energy in constructive ways on all our behalf.

There are undoubtedly some folks and some successes I've failed to mention, and for that I apologize in advance. This has indeed been a strange year for parish ministry, but a fruitful one, none-theless. Our congregation has been thriving despite our inability to gather in traditional ways, and we've added more than a few new members this year. We will take 2021 as it comes and we will be adaptive and faithful as we address whatever we encounter. I am more grateful for Christ Church, her people, and her ministry now, than ever before. I will end my report by repeating words I shared when the pandemic first began. I think they are as true now as they were then:

"We can shut her doors, but the Church never closes. ...the light of Christ burns even in the midst of the darkness of uncertainty, fear, and anything else that troubles us. Our faith isn't about buildings, but about the love of a God who creates us, redeems us, and sustains us. We are the Church. You are the Church. And in this time, unlike any time we have lived through before, don't forget to be the Church. The world needs you and the light of Christ within you, now more than ever."

Associate Rector's Report

2020 was a year of blessings, uncertainty and learning how to do ministry in new ways. Ministry through Zoom and Facebook is a new and now normal experience! Yet, even though there is a pandemic, we feel God's love flow through the congregation of Christ Church and reach out into the community.

Daughters of the King St. Elizabeth of Hungary Chapter, to the Order of the Daughters of the King, is open to all women in the Episcopal Church. Members become part of a life-long program of prayer, service, and evangelism, dedicated to spreading Christ's Kingdom on earth and strengthening the spiritual life of their parish. For their service project, the Daughters picked up Christ Church Tins at the church office, filled them with goodies, dropped them back off (of course following safety protocol) and then the tins were put into the holiday food baskets. If you would like to learn more about how to join the Daughters of the King, please reach out to Mtr. Ashton or one of the Daughters.

Pastoral Care

The Pastoral Care team continues to quietly tend to those who are ill or injured and cannot attend worship services. Visits are made to the local hospital, hospice, retirement communities, nursing homes and private homes. Visits this year are made mostly by clergy, wearing masks and, if possible, outside. Eucharistic visitors take communion and pastoral care visitors provide much needed companionship. Porch visits are the new norm as well as serving communion under special circumstances. The Angel Guild provides meals to families dealing with the birth of a child, illness, surgery, or death of a family member. The Christ Church Comforters ministry makes shawls and lap blankets that are given to the sick. The knitter/crocheter prays as she makes the shawl or blanket and once finished, they are blessed at the altar before being distributed. Our Martha's Guild provides beautiful receptions for families after the funeral of a family member. Thank you to everyone who helps keeps Pastoral Care going strong. If you are interested in serving in any of these roles, please contact Mtr. Ashton.

Flower Ministry

2020 allowed for a new pastoral ministry to blossom and flourish at Christ Church! With the church being closed and the congregation being separated, flowers from the altar started getting distributed. Each week the flowers are taken off the altar and put into bud vases. A personal note is handwritten to each individual or household. Then a flowers and note are delivered that Sunday afternoon. This small ministry, which started with twelve people on a list, has grown and reaches over sixty people a month. Special thanks go to Anna Belle McCaskill, Alice Barlow, Beryl Blatchford, and Ellen Kuehm for getting this important ministry started!

The Thursday Book Study

This weekly women's book study continues to offer a variety of different reading opportunities throughout the liturgical calendar year. We meet at 1:00 pm via zoom. All are welcome. If you'd like to join us, feel free to contact Mtr. Ashton.

Newcomers

The newcomers ministry invites new members of Christ Church into our community. We welcome people by greeting them when they first arrive, by sending them a card and following up with a call from the clergy. Several times a year we hold a newcomer's dinner at the rectory. These dinners give the newcomer committee, clergy, and program staff time to connect with with people who are new to Christ Church. This year, we were able to have one gathering in the first quarter, before in-person gatherings stopped. Yet, through a pandemic Christ Church continues to welcome newcomers.

The Financial Assistance Ministry

The Door Ministry is an outreach ministry of Christ Church that helps to pay utility bills for people struggling with these expenses. Many of those asking for assistance are the working poor who are struggling to pay their monthly bills due to illness or injury. They are most appreciative of our help. Volunteers interview candidates, who must provide proof of identification and an original copy of the bill for which they are asking assistance. In most cases, assistance is limited to \$250 per person, every six months. This year the Door Ministry has paid over \$13,000 to help our neighbors in need.

I feel extremely blessed to be the Associate Rector at Christ Church. 2020 has been a roller coaster ride, nevertheless, an awe-inspiring and grace-filled year of ministry! Thank you Christ Church!

Associate for Children, Youth and Families - 2020 Report

At the beginning of 2020, we started with our regular programing of Sunday School and Youth group following the school holiday break. We had Epiphany King/Queen Cupcakes - whoever found the M&M in their cupcake was in charge of their Sunday School classroom.

Our Children's Chapel, or Kidurgy, as we call it, did not take a break over the holidays, but was still in full swing up and through the holiday season.

I partnered with the ECW board to provide a Women's retreat, with the hope of providing something that would engage the younger women of the congregation. Katie Tippet, the creator of Selah St. Simons Island, was our speaker. We met at Epworth on January 25, 2020. We had 20 women participate and two children - for which we provided childcare. It was a successful day!

In February, the Children, Youth and Family council met to discuss the mission of these programs, our core values, and how to plan events in the future, according to the data we collect. It is in these meetings, that parents and Christ Church CYF volunteers communicate with each other about what outcomes we desire and what can be accomplished. Using Vacation Bible school as an example- it was discussed that a half day program works for some, but a majority of our families have both parents working full-time, so it is difficult for them to engage in our program, when there are other opportunities for full-time care for their children. So we discussed the possibility of adding an ARTs camp in the afternoon, and that was the plan!

We also decided that our Lenten devotion would be to study the Saints of our church. Mother Katie put together packets for home learning for our younger children, and the youth participated in Lent Madness, with a chance at winning the Golden Halo (3 of which, ended up with the Winner, Harriet Tubman, on their bracket!)

In March, the Youth Group took their annual trip to Cumberland Island - 13 of our youth, plus friends and two adult chaperones. Christ Church had just suspended all in-person worship, but the youth received permission to go ahead with our plans. It was a wonderful day of fellowship and fun. We hiked around the southern part of the island, explored ruins, saw wild horses, had a beachside Eucharist, and ate at a restaurant, before returning home.

When covid-19 came to our community, many CYF programs were suspended. However, Mother Katie, with the help of her tech savvy husband, was able to put together Kidurgy videos and provided those videos every Sunday on Facebook early in the pandemic and eventually as a link emailed to participants. We held a few Zoom meetings for Pathfinders and Youth Group, but they were sparsely attended - understandably.

In April, Mother Katie started to schedule porch visits with youth and families to check in safely during the pandemic. These visits would continue through the Summer. We did have to cancel Vacation Bible School and Serving our Neighbors, as well as our Orlando Adventure park visit for all those children and youth who serve in our services as greeters, tech helpers, acolytes and choir members. This year we presented the Kriemborg Cross and scholarship to three very deserving youth - Isabel Parker, Nathaniel Steelman, and Waverly Brown. We presented a video of them receiving their cross this year, since in-person worship was not possible. It had a very positive response, with requests to do the video in the future, whether we are in a pandemic or not.

Fall came and with numbers of COVID cases going down, we looked into the possibility of having out-door youth group on a regular basis. We got the go-ahead from Christ Church and approval from the Vestry. We started meeting on Sunday, September 27. Attendance has been pretty steady - around 8 youth and 2 adults, with occasional peaks and valleys.

With the help of Ed and Lynn Turner, we attempted a Zoom Sunday School classroom, starting on September 13. We had great attendance for the platform - often around 12 children/youth that participated. We followed the Sparkhouse curriculum and provided this up until the season of Advent.

We heard in late October from a few parents who were grateful for our virtual lessons, but expressed a desire to have an in-person fellowship for their children and themselves. We started with outside in-person worship in September and those services went very smoothly. So, we collected some data from our parents from a survey we sent out and determined that a family oriented, child-centered service was worth pursuing. We started the first week in Advent and used Advent as our testing season to see if we should carry through with the service. Our attendance matched our other tent services - in the mid to high 20s every Sunday. We made plans to bring it back in the Season of Epiphany in 2021.

Even though a public Christmas Pageant did not seem possible for Christmas of 2020, we did not let that stop us from putting together a Pageant movie that several of our children and a few youth participated in. We recorded each part separately and among our life-sized nativity on the Christ Church front yard. It was a joy to see our young people retelling of the Christmas story on Christmas Eve this year, even if it wasn't exactly the same.

The pandemic presented the Children, Youth and Families with many challenges this year. Some of the most Christ-centered work involved our porch visits, where we checked in to see how children and parents were coping with the added stress and pressures on each member of the household. It was challenging, but a privilege to be invited in to share those sacred moments with our Christ Church Family.

Seasonal Associate's Report

My six months (December-May) spent with you were very different than in previous seasons.

While I continued teaching, assisting with weekend worship, and visiting with the sick, almost everything took place virtually. COVID prevented most face-to-face interactions but didn't prevent our connecting via phone calls and Zoom visits.

While we couldn't have our fun receptions and special events, I treasured connecting with many of you in local shops and grocery stores. Backpack Buddies carried on and was a wonderful way to see some of you as we packed food bags to meet the needs of our neighbors with food insecurity. And we refused to let COVID prevent the confirmation of six adult parishioners in December. The work of the kingdom of God continued in new and different ways, thanks to your perseverance and determination.

On the diocesan level, I continued to work with churches and vestries throughout the diocese who found themselves in transition as their rectors left, or found themselves in conflict, or were planning for their future. I continue to serve on the Disciplinary Board and chair the Honey Creek Commission. I normally coordinate and am lead facilitator for the week-long Conflict Transformation training for clergy offered annually and am a trainer with the Church Development Institute. These trainings could not be held, but we are making plans for these programs to again be offered in 2021.

I love my time at Christ Church and working with all of you, virtually and in person. Know that you are missed during the time Uli and I are away and you remain in our prayers.

From the Organist/Choirmaster - 2020 Music Program

2020 started out with a typical schedule for our music program consisting of an weekly rehearsals for our Adult Choir, Handbell Choir, Choristers, Trebles, XChoir, three to four weekly Liturgies, funeral services and weddings.

Who would have imagined in March 2020 everything would change? Technology is now the norm. Large quantities of rehearsal tracks are recorded each week that culminate in a combination live/video produced online services. My weekly recording process consists of the following:

Hymns, Anthems, Psalms in any voice combination (Soprano, Alto, Tenor, Bass, 2-part, etc.)

- Lay foundation piano track for each selection
- Record individual track over the foundation track using a highlighted voice such as harpsichord for EACH voice part
- Format music in pdf
- Send email to each choir member with instructions
- Report usage and compile copyright information for the bulletin and Livestream

Weekly Email to the Music Team

• An email for the upcoming Sunday goes out a 7-9 days prior. The deadline for our music team to email or Airdrop their recordings to me is Thursday (4 days prior to Sunday).

- A Dropbox folder is created for each Sunday; inside that folder are individual folders holding all individual vocal and instrumental tracks for each musical offering (opening hymn, anthem, sequence hymn, etc.)
- Fr. Tom (or Glenn on occasion) layers each track into an audio file. We tweak balance if needed and then the selection is "finalized" into the video you see on the Livestream.

Several Joyful Voice Ensembles (handbells, world drumming, etc) began in September

- Rehearse selected composition (each ensemble does not exceed 6 people for 45 minutes)
- Record the composition
- Add additional tracks to complete the recording and send to Dropbox

Special Recorded Liturgies with Music Focus

- All Saints Day Cemetery Walk was a huge success that will most likely be repeated
- Stations of the Cross is almost complete and will be released in the coming months

September 1, 2020 marked the 10th anniversary of my return to Christ Church for which I am very grateful. In this surreal year, my biggest thanks and admiration go to Fr. Tom and Glenn who spearhead the technology to keep us together as a Parish. And to top that, we have a fun, strong and talented staff and music team. I am blessed to be a part of it.

ECW Annual Meeting Report - 2020 and Looking Ahead

Christ Church ECW has a surprising number of happy events to report in this difficult year of 2020! We launched in January with a first-ever (or at least in recent memory), Women's Retreat at Epworth-by-the-Sea, Enriching our Spiritual Lives through Gratitude, led by Katie Tippett, founder of Selah St. Simons and spiritual coach.

In February we celebrated our women clergy with a festive luncheon, self-catered by the ECW Board (mimosas and all!), including a slide show and statements of recognition of Mothers Ashton, Katie and Becky by women who have been touched by their support and leadership.

Another delicious annual Frederick Cousins Guild Oyster Roast rounded out the month of February and, as it turned out, all social gatherings in 2020.

Though, sadly, the hard work of our Tour of Homes Chair, Susie Henning and Co-Chair, Tami Black with all of their teams wasn't able to be realized in March due to the pandemic, the generosity of the community was a big bright light that allowed the ECW's fund for women and children to award grants totaling \$35,000 to local charities despite cancellation of the 2020 Tour. We – and the organizations supported for so many years by this fund – are grateful to the 2020 Tour Sponsors, Benefactors, Homeowners, and ticket-purchasers, as well as the many people who purchased cookbooks, cookies and aprons to make these grants possible.

While gatherings stayed on 'pause', the work of the ECW Scholarship Fund also continued. Scholarships were awarded to Ma'Kayla Hulett, Waverly Brown and Hannah McKay Martin in socially-distanced outdoor presentations in July by Paul White, representing the Community Foundation and members of the ECW Board.

In a tough year it was wonderful to see that November and December again brought the annual Holiday Gift Baskets ministry, led by Jeannie Wade, which provided for 25 families at Thanksgiving and Christmas. At Christmas, each family also received a gift certificate, all thanks to generous donations from parishioners.

Especially in this year of great challenges, the ECW Board thanks all of the women of the parish who

contribute so much day in and day out in service to each other, the parish and the community.

We look ahead to 2021 knowing that, like 2020, it will be "different". Recognizing that the pandemic will again make a Tour of Homes unsafe and has prevented sales of cookbooks and such, we will soon be reaching out to the community to request support for grants to local charities supporting women and children. Organizations have depended on our support for years – some for the full 68 years since the first Tour. We can't let them down when the need is even greater than usual.

Mission and Ministry Report

During 2020 Christ Church, through the Mission and Ministries committee, continued to provide ongoing monthly financial assistance equaling approximately \$31,000 of our \$50,000 budget to a number of organizations including Union Memorial Cemetery, Shepherds for Seniors, Our Journey, Manna House, International Seafarers, and Faith Works. These organizations provided needed services to a range of people in need. This financial assistance is a continuation of assistance that has been provided for a number of years.

In conjunction with the Glynn Episcopal Ministries (GEMS), funds have been provided to target specific activities at Burroughs-Mollett Elementary School including the Accelerated Reader Program that provides incentives to youth who read beyond what is required. Committee members and others also contributed time to serve as readers and to participate in activities initiated by the school library. Also individual tutoring for a limited number of students has been provided when possible.

This year a significant amount of designated Mission and Outreach money has been combined with other funding sources for pandemic relief providing assistance to families affected by lost employment and to St. Athanasius to assist with revenue shortfall. Additionally, funds were made available to help with the purchase of face masks for students and staff at various schools in the system.

The focus of Mission and Ministries has been broadened to organize and capture the contributions made by Christ Church beyond the financial assistance given. Through a combination of financial assistance and volunteer activity, it is hoped that we will have a broader impact of shaping the focus of the services provided.

Christ Church Backpack Buddies and Hunger Outreach Ministry

The year 2020 has been a record-setting year for the Backpack Buddies Program. This is attributable to the pandemic-related school closures and economic downturn. The demand for food bags reached unprecedented levels during the March through December period.

During 2020, the backpack buddies team packed and distributed 21,904 weekend food bags to children and families in need. Averaging around 13 food items per plastic storage bag, our effort entailed packing approximately 285,000 food items weighing just shy of 99,000 pounds!

Schools and agencies served have increased as well. Our bags are serving homeless teens at Safe Harbor's Street Beat program, and Children in Action after-school sports camp, Burroughs Molette, St. Simons, Oglethorpe, Golden Isles, Glyndale, and C.B. Greer Elementary Schools. We conclude 2020 serving 540 children weekly.

The Program has also been record breaking in terms of donor support. Revenues for 2020 are \$56,977, and expenses total \$48,023. Schools are adding children almost every week, so we welcome new donors as well as our steadfast supporters! We are grateful for our partnership with America's Second Harvest of Coastal Georgia, who is our main supplier of food at unbelievably low prices.

Christ Church continued to partner with St. Athanasius, our sister GEM Episcopal parish in Brunswick, to distribute groceries to adults in need every two weeks. Christ Church parishioners provided countless grocery items and canned cash for the 1300+ bags we distributed after reactivating the pantry in the second half of the year. Christ Church financials for the Feed My Sheep pantry in 2020 are \$2,712 in revenues, and expenses of \$1,467. St. Athanasius is a major financial supporter of the pantry as well. We were fortunate to distribute over 13,000 pounds of fresh fruits and vegetable as well as some dairy and eggs through Second Harvest's participation in the USDA's Farms to Families program. These boxes were made available at no cost to Christ Church through pandemic relief funding.

In addition to the thousands of washable masks Christ Church provided when school resumed, Backpack Buddies provided thousands of disposable adult and children's masks to households this spring and summer. These masks were generously gifted by several program supporters. A huge shout-out to them and all 40+ individuals who have brought or shipped food and helped order, pick up, unload, disinfect, organize packing tables, pack, recycle plastic and cardboard, and deliver food bags week in and week out, rain or shine or 110 degree heat index. YOU AND OUR MANY FINANCIAL DONORS ARE HEROES!!

2020 has been a landmark year in Christ Church's outreach to the hungry, but I believe I speak for everyone involved in saying that it has also been a landmark year in terms of rewards. We've received as much joy, if not more, than those we have served.

Treasurer's Report

Wow; 2020...how do you begin to summarize this challenging year? I must start by thanking Father Tom, Glenn Queener, and ALL of our amazing staff who faced incredible challenges because of the pandemic and, yet, continued to offer meaningful ministry in new and inspiring ways to provide us the spiritual nurturing that we needed more than ever. In addition, many volunteers assisted with our financial management, again, during trying times. We are grateful to the leadership of Kim Chitty, who serves as the chair of our Finance Committee and to Cynthia Atwood, Lisa Torbett, Beryl Blatchford and Alice Barlow who also serve on the finance committee.

In addition, there are many devoted members of our church who serve as Tellers. We are thankful for our Head Teller, David Blatchford and for all that served on this team with him (Bill Abbate, Henry and Diane Ansley, Beryl Blatchford, David Boland, Oscar Covington, Dave Davis, Lee Dyson, Peg McBride, Dale Pierson, Paul and Annabelle Salter, and Susan Shipman). Our tellers closely follow the practices suggested by our accountants, Barr, Coiner and Lumpkin. Our Vestry met virtually to go over the audit report for 2019, and we once again received a very positive report from the auditors in regards to our financial management practices.

Because of the generosity of so many parishioners and the good fortune of PPP funds, it appears that we will end the year with a surplus of approximately \$106,679. We continue to allocate financial reserves for unexpected maintenance for the church and the homes that we own (and these balances are shown on our "overview" page). Even with this approach, the Vestry did agree to take \$100,000 from our endowment to have much needed painting done and to replace the windows in the Parish House. We also made repairs to the Parish House for water damage that was found on one of the walls and we repaired the Winn Building roof.

In regards to our income, our "pledge and non-pledge" income surpassed last year by \$50,617 and we are grateful to those that were quite generous with their gifts, particularly in December. This generosity was reflected in many additional gifts to Outreach and our parish should take great pride in the way that we have positively impacted our community through Backpack Buddies, our holiday baskets, and our Rector's Discretionary Funds, along with our Outreach Ministry. "Other" income was significantly reduced for the year (visitor donations, wedding income, tour bus income, etc), so that our overall income was reduced by 2% from 2019. Thanks to the prudent expense management by our staff (who kept us at 96% of what was budgeted) and the PPP loan that has now been forgiven, we were able to end with the small surplus mentioned previously. While the surplus is somewhat encouraging, we did feel cash flow stress a few times during the year, as we are dependent on "pledge" and "non-pledge" income to be able to fund our operations in a timely manner. Because of the lack of "in person" gathering, income did flow into the church in a more sporadic manner than usual. We are thankful to all that have made pledges for 2021 and we will continue to encourage our parishioners to generously support our ministries throughout the coming year as they can.

We are pleased that our year-end endowment statements report "net gains" for all accounts after the draws that were taken to support our operations and capital improvements for the Parish House.

Our financial statements include a summary of our "Rooted. Growing. Building." campaign. While we started the year with great optimism about this campaign and what it means for the future of our parish, we temporarily put this campaign on "hold" once the pandemic hit. We are grateful, however, to those that did continue to make pledges during the year. The gifts that were given and the expenses that were incurred as we continued to work on various projects related to the campaign are included in the financial packet. We look forward to finishing the solicitation for this campaign later in 2021!

Last, I'd like to offer a special "thank you" and "good luck" to Stan Kyker who has served as our Financial Administrator for over seven years and has chosen to "really retire" again! We are grateful for the many positive contributions that Stan has provided us and we wish him well in the days ahead.
