OPEN FOR BUSINESS DURING COVID-19

HBAV successfully advocated to the Governor of Virginia to keep construction open March 12 to May 15. Business remained open for our members while many other states across the nation were SHUT DOWN. In addition, HBAV:

- Ensured that Local Building Permit and Inspection offices remained open
- Local courthouses continued to process land records
- Local Governments were allowed to meet electronically to approve land use decisions

IMPACT FEES

Successfully defeated two pieces of legislation that would have allowed localities broad authority to impose impact fees on all new home permits.

- Saving a minimum of \$5,000 per home, up to as much as \$20,000 per home (as in Maryland)

LOCAL BUILDING AND ENERGY EFFICIENCY CODES

Virginia's uniform statewide building code provides one code for Virginia, predictively and clarity for builders and home buyers. HBAV worked to defeat legislation that would have allowed each local government to adopt different building codes, as well as energy efficiency standards for each development.
