Clerk's Report – (report provided)

 August 23, 2025 Joint Meeting – Boise and Kendall Presbyteries Report – Featuring the unanimous approval of the submittal of a plan to merger Presbyteries to the Synod of the Pacific.

Pastor's Report – Rev. Kevin Starcher

 Presented the framework for our discussion during the Visioning and Prayer section concerning our budget, program and personnel missional needs and priorities for 2026.

Building and Grounds – Alex Wolff (documents provided)

- Discussion of 2 Facilities Use Requests
 - Building Facilities Request #1- Born to Succeed Early Care and Education Center event- December 6, 2025.
 - A motion was made by Elder Alex Wolff on the behalf of the Building and Grounds Committee to approve this request. On a voice vote, the motion was carried unanimously.
 - Building Facilities Request # 2- Delta Kappa Gamma Education Event June 8-10, 2027, 8:00 a.m. -8:00 p.m.(CPC Member Request). After discussion it was decided that we could not commit to the availability of the requested area two years in advance considering the current level of programing during that part of recent years. - Recommendation -Motion made by Elder Brian Grant for the Mission Committee for approval to combine the pledged support for the Presbyterian Church's Peace and Global Witness fund with any excess being directed to support Shelvis and Nancy Smith-Mather Missionary work in South Sudan. - Introduction of Shelvis Smith-Mather and wife Nancy's missionary work with South Sudanese people in that war-torn country and in refugee camps just across the border in northern Uganda. Shelvis Smith-Mather will be attending Covenant to share about their ministry October 5th.

Visioning and Prayer Time

- Flourish and Grow Updates
 - Elder Tracy Saurerwein provided updates on the Flourish and Grow project Capital Campaign project outlining the organization, steps, process and goals. A tentative project cost (and project goal of \$1.8- \$2 million dollars was targeted).
 - Further discussion was held concerning actions to be taken if the Goal is Not Met or if it is Exceeded.
 - After further discussion a motion was made by Elder Bill Martin and Tracy Sauerwein that:
 - If campaign receipts fall short of the established goal, the Campaign Steering Committee will recommend to the Session a revised project scope consistent with the funds received. The projects in this campaign will be prioritized from highest priority to lowest as follows:
 - 1. Power Upgrade & Carpeting replacement
 - 2. Kitchen expansion
 - 3. Multi-purpose room
 - 4. Sanctuary platform expansion
 - If receipts exceed the established goal, they will be used to retire our existing mortgage (around \$370k). If we raise more than the payoff amount from our mortgage, we would place those monies in Covenant's endowment fund, so that the principal will generate interest we can use for

annual operating expenses into the future. On a voice vote, the motion was carried unanimously.

 A discussion ensued concerning budgeting and missional priorities as we get ready to prepare a budget for next year. Rev. Danni Forbess shared ideas and possible priorities for programs that have been discussed. No action was taken.
