Lifting of Restrictions

Loss of Privileges will be lifted as follows for the state observed Holiday – Memorial Day starting at 8:00 am on Saturday, May 23, 2020 and ending at 10:00 pm on Monday, May 25, 2020.

- Level 1 **no lifting of holiday LOP**
- Level 2 lifting of LOP on actual holiday only
- Level 3 lifting of LOP for entire holiday weekend.

Privileges restricted by an AIC Management Plan issued by the Security Threat Management Unit are not lifted during Holiday periods. These restrictions remain in effect and should be enforced until the date specified on the AIC Management Plan.

This does not restrict normal operations and progressive discipline, such as cell-ins or transfer to segregation for poor behavior that may be seen as a threat to others and/or the safety and security of the institution.

1a). We will gradually go back to normal in phases (like the rest of the department). Right now we are in Phase 1 and AIP programs have started back up. We will continue with our current modified operations until otherwise directed.

2a). Visiting will not begin until Phase 4. At this time, there is no date set for Phase 4.

Ramos Project



On April 20, 2020, in *Ramos v. Louisiana*, the United States Supreme Court ruled that the Sixth Amendment to the U.S. Constitution requires unanimous jury verdicts for a conviction in a criminal case, striking down Oregon's non-unanimous jury law. From now on, all jury convictions require unanimity in criminal cases.

What does this mean for you?

1. If your case is currently on direct appeal (and you do not yet have a final judgment), then contact your appellate attorney.
2. If your case reached a final judgment (meaning you have completed your direct appeals), then whether you can benefit from the *Ramos* decision will depend on litigating numerous issues including its retroactivity through the post-conviction relief (PCR) process. This process will take time. People in custody impacted by the decision will not be immediately released.
3. Despite the impact of COVID-19, we have provided resources to you through your law libraries.

What is the Ramos Project and how we can help you?

The Ramos Project was developed by Professor Aliza Kaplan, Director of the Criminal Justice Reform Clinic at Lewis & Clark Law School and O'Connor Weber LLC, a private appellate and PCR law firm in Portland. The Ramos Project's initial goal is to provide information (to anyone who thinks that they may have a PCR claim because of the *Ramos* decision) and assistance in filing their pro se PCR petition.

OCE Clerk Support CADD Department

OCE is now accepting applications for a **Clerk** located currently in the CADD Department at Oregon State Penitentiary (OSP). This recruitment will be used to fill one (1) position. Workers holding this position must have experience using Microsoft Office software and performing standard clerical duties. The work schedule is Monday – Friday, 6:00am to 2:00pm. This position awards 12 PRAS Points starting with the opportunity to earn a matching Team Goal Award as well.

All applicants must meet the following qualifications:

- **Must have a valid social security number or equivalent.**
- Have NO convictions for ID Theft or Computer related crimes
- Must be incentive level 2 or 3
- Have at least 60 months remaining on sentence
- Have six months clear conduct
- Have NO program failures in the past 6 months
- Microsoft Office experience with a preference in Excel and database knowledge.
- Ability to learn new processes including purchasing, sales, estimating, and product specifications.
- Be able to type 30 GWAM including 10 key.
- Possess a high school diploma or GED certificate, or be in the process of obtaining a GED certificate within a specified period of time (verified by DOC Education)
- Be able to work efficiently and professionally at all times as a member of a team in an office environment



Be willing to sign a twelve (12) month retention agreement- anyone leaving the assignment either by termination or resignation before serving the full retention period will be returned to the sending institution

All applicants will need to pass a DOC/OCE security screening and OCE interview before being considered for the position.

Change of Correctional Communication Systems Vendor

DOC is currently in the process of transitioning the correctional communication system (phones, video kiosks, and tablets) to our new vendor, CenturyLink. This project will be completed in multiple steps.

Step 1: Upgrade the phones in all facilities. In this step there will be no change in service provider.

Telmate/GTL will still provide all services.

Step 2: Change out of Video Stations, Tablets, and Network

In this step, services will be changed from Telmate/GTL to CenturyLink.

This process will be staggered across the facilities (not every facility will transition on the same date).

Each facility will be cutover as soon as the equipment installation at that location has been completed.

The planned schedule for the change to CenturyLink is;

Week 1: DRCI, CRCI
Week 2: SFFC, OSP, TRCI
Week 3: EOCI, SCI, MCCF, OSCI, SCCI
Week 4: WCCF, SRCI, PRCF, CCCF



Please keep in mind this schedule is subject to change. Week 1 is set to start Wednesday, June 3, 2020.

Important information about the change to CenturyLink

- The funds on your Telmate/GTL account at the time your facility changes to CenturyLink will automatically transition to your new account with CenturyLink.
- The funds that your friends and family have with Telmate/GTL will not transition to CenturyLink.
- Friends and family members will need to contact Telmate/GTL directly at 1-866-516-0115 to request a refund of any remaining balance on their accounts.
- The messages, photos, and contact information from your Telmate account will not transition to CenturyLink. If you have photos you would like to be saved, contact one of your friends or family members and request they make copies through their Getting Out Telmate/GTL account.
- Friends and family members should monitor the ODOC website or social media accounts for updated information regarding the new vendor. This will include a link to the CenturyLink website: https://www.centurylinkcorrections.com/facilities/or_doc.html, where they can register an account, make deposits, find call and messaging rates, etc.
- Friends and family registration is not currently available. We anticipate the registration be available May 21, 2020, but is subject to change. If the date changes, it will be announced on CenturyLink's website and ODOC's social media pages. Friends and family can register their accounts before your facility is set to transition.
- More information regarding MP3/MP4 devices is coming soon.

We are aware this will be a significant change, but we are doing everything possible to minimize the impact this will have on your communication with your friends and family members. We believe this change will come with a lot of value, including the discounted calling rates listed below.

DOC está en el proceso de transición del sistema de comunicación correccional (teléfonos, quioscos de video y tabletas) a nuestro nuevo proveedor, CenturyLink. Este proyecto se completará en múltiples pasos.

Paso 1: Actualice los teléfonos en todas las instalaciones.

En este paso no habrá cambios en el proveedor de servicios. Telmate / GTL seguirá proporcionando todos los servicios.

Paso 2: Cambiar de estaciones de video, tabletas y red

En este paso, los servicios se cambiarán de Telmate / GTL a CenturyLink.

Este proceso se escalonará en todas las instalaciones (no todas las instalaciones realizarán la transición en la misma fecha).

Cada instalación se cerrará tan pronto como se haya completado la instalación del equipo en ese lugar.
