Overnight Trip Agreement  
(Foreign, Domestic, Service, Retreats)**

Overnight trips arranged through Trinity High School have as their goal an intensive educational, spiritual, social or service-oriented experience that cannot ordinarily be met in a school setting. Our primary concern is for the safety and well-being of students who participate in such opportunities. It is in this spirit of safety and well-being that we require students, parents/guardians and chaperones to adhere to the following guidelines:

1. It is expected that students fully participate in all scheduled activities. If a student is sick or is prevented from participating, she must immediately notify the chaperone.
2. The Trinity chaperone/sponsor shall be the adult designated to have primary responsibility for students of the school.
3. Students shall comply with the Trinity High School Student Code of Conduct and with all rules as stated in the Trinity High School 2019-20 Student Handbook.
4. Trinity's designated chaperones shall have full authority to enforce the rules referred to in #3 and all Trinity High School rules from the Code of Conduct in the Student Handbook. Violation of lock rules and/or the Trinity High School Code of Conduct may result in sanctions upon return to school or dismissal from the lock-in at the expense of the student's family, and may jeopardize future privileges at Trinity High School.
5. Trinity's chaperone(s) in coordination with the trip's sponsoring agency shall set the curfew; students shall adhere to it.
6. Absolutely no alcohol or drugs including but not limited to tobacco, e-cigarettes, or vaping paraphernalia shall be consumed.
7. Trinity students shall not separate from the group or the chaperone without the express permission of the Trinity chaperone for that period of time.
