A limited amount of financial aid will be available for registered students during the 2021/2022 academic year. It is necessary that the directions be carefully followed and all time-lines be adhered to.

January 22nd	Trinity Financial Aid award letters mailed for the Class of 2025
February 10th and February 18th	Registration, including the \$650 non-refundable registration fee, and tuition contracts due for the Class of 2025
March 11th	Parents and/or Guardians of students in the Classes of 2022, 2023 and 2024 who have registered their student(s) will be notified of the amount of financial aid, if any, to be awarded
March 24th	Signed Tuition Agreement form and registration fee due in the business office for the Classes of 2022, 2023 and 2025. The \$650 registration fee is non-refundable

All students are required to participate in Trinity's two student fundraising drives, *Walkathon* and *Raffle*, in order to contribute toward filling the tuition gap (the difference between the actual cost of a Trinity education versus the amount of tuition charged).

To be eligible for any of the financial aid programs, the student must be registered at Trinity High School for the 2021/2022 school year. This includes the completion of the registration form, the tuition agreement and payment of the registration fee.

FACTS Grant & Aid Assessment will be conducting the financial need analysis for Trinity High School for the upcoming 2021 – 2022 school year. Families applying for financial aid will need to complete an application and submit the necessary supporting documentation to FACTS Grant & Aid Assessment by no later than January 18, 2021. Applicants can apply online as of November 17, 2020 at

The following information is required in order for FACTS to process your application:

1. Signed and completed paper application or completed online application.
2. Payment of the \$30 application fee.
3. Copies of your 2019 tax return including all schedules.
4. Copies of your 2019 W-2's for both you and your spouse.
5. Copies of your 2020 W-2's for both you and your spouse once available.
6. Copies of supporting documentation for Social Security Income, Welfare, Child Support, Food Stamps, Workers' Compensation, and TANF.
