

COVID-19 Testing Email (01-14-2022)

You are receiving this email because you have been identified as a Department member that has not provided proof of full vaccination. The County policy requires proof of full vaccination, or submit to weekly testing. These conditions shall be met unless more frequent testing is required under State or local Health Officer Orders. Testing is mandatory and you are required to undergo such testing as a condition of your employment with the County. The Sheriff is directing affected Department members to begin weekly testing on Monday, January 17, 2022, until further notice.

If you believe you received this notification in error, please contact your COVID-19 coordinator.

Personnel are solely responsible for seeking weekly testing and have the option to choose any PCR certified/credentialed testing provider to schedule routine testing, in advance, at a location and time beneficial to the individual and Department operations. Personnel may test on duty, as overtime and mileage reimbursement are not available.

In time, additional testing sites will be made available at additional Sheriff's facilities. The majority of these sites will be open seven days a week during the am/pm shifts, with an overlap into the early morning shift.

Personnel required to test must submit their test verification to their Unit COVID-19 coordinator by **Thursday of every week at 1700 hours**. If at any time your vaccination status changes, you must update your personal profile within the Los Angeles County Sheriff – [Personnel Vaccination Status Portal](#) by [clicking here](#).
