MEMORANDUM

May 12, 2020

To All Litigants, Attorneys and Members of the Public,

On May 11, 2020 the Chief Justice of the Georgia Supreme Court extended the Order Declaring Statewide Judicial Emergency of March 14, 2020 through and including June 12, 2020. Further, by Order of May 12 2020, the Chief Judge of the Cobb Superior Court, Reuben Green, extended the judicial emergency in the Cobb Judicial Circuit.

The State Court of Cobb County will continue to provide essential services via a duty judge rotation through the end of May. The Court is developing procedures, consistent with the observance of all local, state, and federal health guidelines, to resume non-essential court matters.

Additionally, the Court will conduct a limited number of non-essential criminal matters daily through the duty judge rotation. Please contact the assigned judge in your case if you wish to be placed on the duty judge's calendar to handle your non-essential criminal matter.

Other proceedings, including civil matters, may be handled by each judge in his or her discretion through video conference means. Should a litigant or attorney have a matter to bring to the court's attention, that party should contact the assigned judge's office for further instructions.
