**Residential Activity – May 2 through May 8, 2019**

- Seven (7) permits for new single family residences were issued with a combined reported valuation of \$2,067,070. The average reported value was \$295,296, two (2) of which applied to the City's recently adopted 2018 Home Energy Rating System (HERS/Energy Rating Index (ERI) Fee Adjustment Incentive Program).
- Ten (10) permits for additions or alterations to residential properties were issued with a total reported value of \$144,200, six (6) of which were storm shelters.
- Fire repair permit was issued for 609 E. Eufaula St.
- One (1) application for new single family residences was submitted with a reported valuation of \$650,000.
- Three (3) applications for addition/alteration to residential properties were submitted with a combined reported valuation of \$86,500, one (1) of which was a storm shelter.
