Water and Sewer Non-Metered Account Information

Your property currently does not have a water meter to measure your water usage. Per the Municipal Code of Chicago, your water usage is assessed based on factors including building size, lot size and other fixtures as outlined below. The below detail is used to calculate the total current water charge reflected on the front of your bill. The sewer charge is 100 percent of your water charge.

Per the Municipal Code of Chicago, beginning June 1, 2016, and every year thereafter, the annual water rates shall be adjusted upwards, if applicable, by applying the previous year's rate of inflation. This increase is calculated based on the Consumer Price Index – Urban Wage Earners and Clerical Workers (Chicago All Items) published by the United States' Bureau of Labor Statistics for the 365-day period ending on the most recent January 1.

Water-Sewer Tax

Effective March 2017, your bill includes water-sewer tax charges. The revenue from this tax will be used to make certain mandated pension payments. In 2017, the water-sewer tax is assessed at a rate of \$.59 per 1,000 gallons of water and sewer use. For non-metered accounts, the water-sewer tax is calculated based on assessed water-sewer usage, per the Municipal Code of Chicago (see Your Non-Metered Water Account Details). This tax is charged to all non-exempt Chicago businesses and residences, and is billed as a separate line item on the front of this bill.

Garbage Fee

The garbage fee is charged to all properties that receive City of Chicago Department of Streets and Sanitation garbage collection service. The fee is \$9.50 per month per dwelling unit.

Late Payment Penalty

A penalty accrues at a rate of 1.25 percent per month on late balances.
