#### Chuck Ribelin

Tall Timbers has the great privilege of honoring Texas native Chuck Ribelin. Chuck at 90 has been a dedicated bobwhite advocate for years. Chuck first learned about Tall Timbers in the 1990s when he met Tall Timbers President/CEO Bill Palmer. Since then Chuck has become a valuable supporter of Tall Timbers. Thanks to Mr. Ribelin's passion for bobwhite quail and Tall Timbers, we can thank him for kickstarting two important capital campaign initiatives, the Piney Woods Quail Endowment and the Quail Expansion & Recovery Fund, also known as the Chuck & Martha Ribelin Quail Expansion Scientist. Chuck's enthusiasm for quail and dedication to help improve habitat, research and education across the Southeast is contagious. 

# the Cause

The Kate Ireland Dinner & Auction is named in honor of one of Tall Timbers' most treasured supporters, Miss Kate Ireland. It is a fundraising event held annually to benefit the Tall Timbers Foundation, which supports Tall Timbers' research and conservation programs.

Miss Kate, known for her organizational, fundraising and people skills, led the effort to preserve the Red Hills region as a member of the Red Hills Consortium in the late 1980s. She became chair of the Red Hills Conservation Association in 1990. The Red Hills Conservation Association was later merged into a division of Tall Timbers as the Red Hills Conservation Program. It is now known as the Tall Timbers Land Conservancy. Miss Kate would go on to lead Tall Timbers as the Chairman of the Board of Trustees from 1999-2006.



This year, ten percent of our auction proceeds will be dedicated to the Piney Woods Quail Endowment in honor of Chuck Ribelin. With a focus on expanding quail populations in Texas, Louisiana and Arkansas, the Western Piney Woods Quail Endowment supports the Tall Timbers Western Game Bird Director position, an on-the-ground role that is critical to successful quail expansion west of the Red Hills and Albany regions.

The challenges of expanding quail hunting on private and public lands into this region are significant, but Tall Timbers is uniquely positioned to introduce the research-based strategies developed in Albany and the Red Hills to overcome these challenges.

Thanks to Mr. Ribelin's generosity, Tall Timbers was able to place a full-time scientist in the Texas region in 2020, which allows us to implement the Tall Timbers' model across the Piney Woods region. Please join us in honoring Chuck Ribelin.
