First Presbyterian Church of Wheaton, Illinois
Congregational Meeting
Sunday January 30, 2022

The Annual Meeting of the Congregation of the First Presbyterian Church of Wheaton, Illinois was held immediately following the 10:30 a.m. worship service on Sunday January 30, 2022. It was conducted as a hybrid meeting with some participants in person and some viewing the meeting on LiveStream video. A variety of voting options were provided to ensure that all members could exercise their vote including an electronic polling platform and paper ballots.

The meeting was called to order by Moderator Rev. Dr. Kellen A. Smith at 11:33 a.m. who sought and validated a quorum. This Clerk provided additional details on how the quorum was calculated with the same procedures previously used where every Active Member who wished to participate was encouraged to log in to YouTube from a unique email address or cast their electronic ballot in advance with a unique email address were deployed. This process effectively creates a traceable record of participation. An audit after the meeting provided the following results: 68 people cast electronic ballots during the meeting, 53 people voted in advance using the electronic polling ballot, and 29 people cast paper ballots during the meeting.

Moderator Smith then opened the meeting with prayer and after some brief introductory comments where he reminded the assembly of the materials including the agenda, business packet, and annual report were available on-line as well as paper copies, the process for casting a ballot, and that the Session had pre-approved several procedural motions to keep the meeting moving. He then invited Elder Andy Leonard, President of the corporation, to the present his report. Elder Leonard highlighted various aspects of the 2021 Annual Report pointing out some of the accomplishments during the past year. As Session had pre-approved by **MOTION** the receipt of the annual report on behalf of the congregation, Elder Leonard invited Elder Justin Mead, Chair of the Office and Finance Committee (OFC) to the lectern. Elder Mead offered the 2021 Financial Report reminding the gathering that the 2022 Operating Budget would be presented later as part of the Ecclesiastical Meeting. He began by noting that even in the uncertainty of the pandemic and its impact, God has continued to provide citing the generosity, faithfulness, and dedication of the congregation. Through accompanying slides, he reported that the final 2021 financial results included a year-end surplus. He highlighted that total revenue exceeded budget by 8.1% or \$84,000 and total operating expenses were 1.8%, or \$19,000 dollars below budget in large part because the vacant Associate Pastor position kept ministry personnel expense significantly below budget. Additionally, other ministry and building costs remained below budget due to the impact of Covid on attendance and activities and this provided the ability to cover other significant expenses, such as major roof repairs, that were unanticipated and above budget projections. The year-end net income, which was \$142,000 compared to a budgeted deficit of \$26,000, positions the church well to support missions and ministries in 2022. He concluded his report citing the performance of longer-term investments performing well, stable cash balances, and full funding of the per capita allocation. He handed the meeting back to the Moderator, noting that Session had submitted a **MOTION** in advance to close the meeting of the corporation when appropriate and that procedural motion was being recorded as carried.

Moderator Smith then called the ecclesiastical meeting to order and reminded the participants that there will be several upcoming motions which require congregational action. Those individuals who used early electronic voting to cast their ballots would require no further action as their votes would be tabulated at the end of the meeting. Those individuals who plan to vote on each of the motions as they are brought before this body should hold the electronic or paper ballot until all items have been addressed. All votes will be included in the final tabulation and the results will be announced at the end of the meeting.

Moderator Smith brought forth the first **MOTION** to approve the minutes from the Stated Congregational Meeting held on Sunday, January 31, 2021 and the Called Congregational Meeting held on Sunday, August 29, 2021 and to dispense with the public reading of those minutes. He asked individuals who had

not submitted an electronic ballot in advance of the meeting to vote “yes”, “no”, or “abstain” to approve the 2021 Congregational Meeting Minutes.

Rev. Smith then provided his State of the Church report. He reflected on the challenges of the year and reflected that he would be happy if he never had to use the word “unprecedented” again. His presentation focused on the vision of the church as it moves forward. He noted that “getting back to normal” is most likely not the direction that the church should strive but rather transforming into a new community of believers. He offered Psalm 139:14, as a way of recognizing that all things are “fearfully and wonderfully made” even in difficult times. He expressed gratitude to his family and the congregation for ongoing commitment and support as he looks optimistically towards the future.

Moderator Smith then invited Elder Emily Herndon, Chair of the 2021 Congregational Nominating Committee (CNC) to present the slate of nominees for Elders, Deacons, and the At-Large Members of the 2022 Congregational Nominating Committee. She reviewed the work of the committee during 2021 and explained the process used by the committee to build the slate of candidates. She thanked the committee for their efforts. She presented the candidates for the Office of Elder (Class of 2025) as follows:

The Congregational Nominating Committee consists of five (5) At Large members elected by the congregation, two Ruling Elders appointed by Session, and two seated Deacons appointed by the Board of Deacons. Elder Diane Easter will serve as Chair in 2022 as she was the Co-Chair in 2021. Session will appoint a seated Elder to serve as Co-Chair for the 2022 committee. Deacon Lindsey Cochran served as one of the two Deacon representatives in 2021 and will continue in 2022 and a second Deacon will be appointed by the Board of Deacons.

Elder Herndon reminded the assembled body that the entire slate would be voted on at once and that nominations from the floor would not be accepted at this time but that a communication and request for additional nominations had been made to the congregation when the slate was announced, and no additional nominations had been received. The pre-approved **MOTION** from Session to close the nominations and to accept the slate as presented could now be considered. Elder Herndon invited those individuals who had not voted in advance to make a selection on either the electronic or paper ballot. She reminded people to not submit the electronic ballot until instructed to do so. She closed her presentation by

stating that Session had pre-approved a procedural **MOTION** to dissolve the 2021 Congregational Nominating Committee with gratitude and thanks and that individuals could act on that motion at this time.

As the agenda then progressed, the Audio/Visual (A/V) Team connected with Elder Annette Shoemaker, Chair of the Generosity Team, via a video. Elder Shoemaker began by thanking the members and friends for the incredible generosity during another year influenced by the pandemic noting that the congregation continued to support the church throughout these difficult times. She reported that total contributed and pledged giving has declined overall in nearly every faith community and house of worship. Similarly, the results of the 2022 Generosity Campaign, “A Generous Life”, also showed a decrease of 4% compared with 2021 and a 7% decrease compared to 2020. Nonetheless, unpledged giving has continued to increase consistent with overall charitable and faith-based giving trends. She expressed encouragement that there were nineteen new pledges for 2022 and \$112,000 in new or increased pledge commitments. The importance of committed pledging, however, as contrasted to unpledged giving, cannot not be minimized. Session must build the forecast and approved operating budget on committed revenue to avoid a deficit budget. Many individuals and families responded positively to the “A Generous Life” campaign and to Rev. Smith’s message that “giving is not debt we owe, but a seed we sow.” As such, Elder Shoemaker announced the relaunching of the Generosity Team, with the goal of further enhancing a culture of generosity in the church with ongoing impact stories throughout the year.

Elder Justin Mead returned to the lectern to present the approved 2022 Operating Budget. He began by thanking the Office and Finance Committee (OFC) and the staff for pulling together the necessary deliverables for Session to approve the budget. He noted that there were a few key concepts that impacted the budget planning process this year. First, the number of pledge units declined slightly even though the overall revenue forecast remained stable. Secondly, the impact of the pandemic remains a factor and may influence the ministries, programs, and financial support of the church and its members for an extended future. In light of the uncertainty, OFC took a conservative approach to forecasting and planning. Lastly, in line with higher inflation trends in the broader economy, the team built in significant cost increases for a variety of goods and services that the church procures, driving up our facilities and maintenance costs.

By way of specific budget detail, Elder Mead noted that the 2022 Budget approved by Session includes:

- Estimated total revenue for the year of \$1.052M and total operating expenses of \$1.069M with an anticipated net operating loss of \$16,000.
- Non-operating income, approximately \$30,000, will provide a projected net income of \$13,000 on the year.
- Estimated total revenue is a 1.7% increase over 2021’s budget and 6% less than actual revenue for 2021.
- The 2022 estimated revenue projection is based on pledges received to date and estimates for unpledged giving, based on recent trends.
- There are some significant cost increases across the board for maintenance, utilities, and supplies related to inflation trends in the broader economy. Most vendors are increasing their fees significantly.
- Per Capita continues to be funded in full.
- Allocation to Mission remains at an estimated 10% of revenue.

Session, as supported by OFC, believes that this budget represents a fair, prudent approach for the year, with equal possibility for actual results to be either better or worse. He emphasized again the need for members and friends to make and keep pledge commitments.

Moderator Smith invited Elder Steve Van Oss to the podium to address both the Human Resources Committee (HRC) report and the Associate Pastor Nominating Committee (APNC) report. Elder Van Oss began with a review of the staffing changes from 2021 including celebrating the music ministry of Kedrick Armstrong as he moved on to graduate school after four years and Alice Lechiara's tenure as financial assistant and manager. He noted that transitions occurred with Dr. Dan Sommerville joining as Director of Music Ministry, Beth Spiegel as Finance Manager, and Jordan Stevens as Director of Student Ministry. He reported that as 2021 came to a close and it was evident that there would be a financial surplus in the overall operating budget, Session was approached to approve a year-end bonus for both hourly and salaried staff since a cost-of-living increase was not provided in 2021 and is not planned for 2022. During 2022, HRC is preparing for transitions for Tammy Brokaw as Office Manager and Chandra Gravit as Director of Children's Ministries including over twenty years with the First Pres Preschool.

Since Elder VanOss is also serving as the Chair of the Associate Pastor Nominating Committee (APNC), he moved briefly into a report on the APNC progress. He stated that the committee has resumed meeting after a short break during the holidays and are actively reviewing applications to identify a candidate for Associate Pastor. He asked the congregation for ongoing prayers and to anticipate further communication updates as appropriate.

He then moved to the approval for the Terms of Call for Rev. Dr. Kellen A. Smith. He reminded the group that it would not be necessary for Rev. Smith and his family to leave the room since the approval would be tabulated using both paper ballots and electronically in advance and during the meeting. The following Terms of Call were approved by **MOTION**:

- Annual Cash Salary = \$75,222.84
- Housing Allocation = \$50,000.00
- Continuing Education Reimbursement = \$2,000.00
- Automobile/Professional Expenses Reimbursement = \$3,000.00
- SECA Offset (up to 50% of SECA Obligation) = \$9,579.55

Elder Van Oss reminded the assembly of the process for voting and that Session had pre-approved a motion to approve the Terms of Call for Rev. Dr. Kellen A. Smith as he asked participants to cast the electronic ballot with "Yes", "No", or "Abstain".

This clerk then approached the lectern and offered a request for Elder Commissioners to represent Wheaton First at assembly meetings of the Presbytery of Chicago. He explained the role and invited interested ordained Elders to contact him directly.

Moderator Smith provided the congregation the steps necessary adjourn the meeting by **MOTION** and explained that the ballots would not be tallied. Dr. Dan Sommerville led in the singing of "To God be the Glory" while the votes were tabulated. The audio-visual team provided the final results to Moderator Smith and this Clerk. Moderator Smith announced that all motions carried and he provided a closing benediction and prayer at 12:15 p.m.

Congregational Nominating Committee 2022 Annual Report

In late winter of 2022, the Nominating Committee met to fill 1 Deacon vacancy. Sandy Nielsen (Class of 2024) was nominated and approved at a congregational meeting.

This past fall, the Nominating Committee met to fill a third of the Deacon and Elder Boards. Elder and Deacon terms are three years in length. Nominating Committee members serve for one year.
