<p>Joy and Maddie mentioned the process for drafting the consolidated application for the funding and how the Systems Performance Committee can contribute. The Sacramento CoC must submit a consolidated application that has three major parts: -CoC Application, Project Applications and CoC Priority Listing.</p>			

The 2021 score for Sacramento increased, however there will be changes to the application this year by shifting away from COVID response and back to traditional measures. Homebase will be leaning on SPC to provide insight to improve system measures. Targeted emails, a survey, outreach to individuals with specialized expertise and 1:1 meetings will be done with the members of SPC as they pertain to different areas of the presentation that can help influence the NOFO application.
