**CVOA Funds** - your \$50 per person non-refundable reservation fee to CVOA will be used to cover group expenses such as bus driver gratuities, a party one night, pre-trip and post-trip parties, at the discretion of the trip leader.

**Trip/Travel Insurance is HIGHLY recommended**; you can purchase it through TravelSafe, using the link in the left column of the Great Events & Escapes website, or you can use any other travel insurance company. Purchase your insurance when you make your \$500 payment to GE&E in September.

**Travel to Boston:** You are responsible for getting yourself to BOS.

**At BOS:** You are responsible for getting yourself to the correct gate.

**Checked Baggage Fees on United:**

- First Checked Bag is \$35, Second Checked Bag is \$45. (before pre-pay discount)
- United accepts one ski/pole bag and one boot bag as one piece of checked luggage.

- If you do not have experience traveling with ski equipment, ask someone who does.

**Transfer between Boise and Sun Valley Resort-** This is included in the package, and it is 152 miles. If you choose to do your own air and transfer (deduct \$410), factor in your transfer cost.

**Groceries -** We will stop at a grocery/liquor store on the way to Big Sky, subject to change or cancellation prior to trip.

**Lift Tickets:** Adult 5-day lift ticket included in package

6<sup>th</sup> day adult lift ticket add \$60

4 day adult lift ticket deduct \$50

For "No lift ticket", deduct \$330 from package price.
