LEADERSHIP ELIGIBILITY

- Only Active Members, Life Members, and Retired Members, in good standing are eligible to hold the position of an elective office (President Elect, Vice President, Secretary/Treasurer) or Board of Governors.
- NYSDA Delegate/Alternate: Ninth District delegates to the NYSDA HOD may be selected from the Executive Committee, past and present members of the 9th District Board of Governors, past presidents and members at large. The president, president-elect, vice-president, secretary-treasurer and immediate past president shall be nominated by the Nominating Committee to each hold the position of NYSDA delegate. The Nominating Committee is urged to also select a member, who in the committee's opinion is representative of the new dentist membership. The Nominating Committee should consider in the selection process at least one Delegate from each of the five counties that comprise the Ninth District. If a county does not recommend a representative delegate, then one will be selected at the discretion of the Nominating Committee. For the purpose of selecting NYSDA delegates and alternates, membership is based on the county where the member practices or last practiced before retirement.
- ADA delegate nominees shall consist of the following: 9th District trustee, current president of the 9th and one member of the NYSDA HOD chosen by the Nominating Committee. The first and second alternate delegates to the ADA shall be the president-elect and the vice president of the Ninth respectively. The Nominating Committee shall choose one alternate delegate from the remaining NYSDA HOD members.
