Plaintiffs present by attorneys Cruz, Felton, and Hormuth. Defendants present by AAG Bracey and AAG Bautista. Amici present by attorneys Snider, Mannion and Furton. All counsel appear telephonically. Prior to the hearing, the Court had received and reviewed Plaintiffs' pleadings, including the Verified Complaint for Injunctive and Other Relief, Plaintiffs' Motion for a Temporary Restraining Order and Preliminary Injunction, and Plaintiffs' Memorandum in Support of a Temporary Restraining Order and Preliminary Injunction. The Court also received and reviewed Defendant's timely filed Appearance and Response to Motion for Temporary Restraining Order. Lastly, the Court received and reviewed the Amici pleadings submitted by the collective Amici, and has entered the proposed written Order granting leave to file their brief in support of their interests. The Court has entered a written Order setting forth the Court's findings and reasons for the issuance of the temporary restraining order. Defendants shall answer Plaintiffs' complaint on or before April 30, 2020 and the cause is docketed for further case management conference to discuss the status of the next stage of litigation, which is a hearing on Plaintiff's pending motion for the issuance of a preliminary injunction.
