I ask that all members stay in contact with your Building Association Representative. They have been trained on the process for Accommodations and Leaves. If you had an accommodation denied you must contact the Superintendent asking why it was denied and what accommodation can be made.

Each school is supposed to have a Pandemic Committee, Leadership Team, and TALC. These groups should be operative to ensure that you have PPE and social distancing properly arranged in your building. If these committees are not active in your building contact your administrator and Building Association Representative.

Your concerns were presented to the Superintendent and his Senior Cabinet on Wednesday, October 14, 2020. Many of your questions regarding PPE, PD, and curriculum were answered. I will send the report from this meeting in a separate update so please check your email.

The HSSC sent out two emails to the maintenance department requesting certifications and updates of all schools being ready for use. That letter was sent on August 27, 2020 and again on September 16, 2020. We are still waiting for a response but in the meantime Mr. Lambkin has been assuring the EOEA that issues that could possibly keep us from working have been resolved. Please keep in mind while you are reading this that when we left in March, COVID-19 was not in any schools except one. That school was cleaned and no one was allowed back until recently. I am asking that we continue to practice safety when in the buildings to avoid the spread of any germ especially COVID-19. Superintendent Hasan and Ms. Brooks (District BA) are inspecting all schools to ensure buildings are up to standard. Updates added to the list I previously sent last week are:

- We are working with the Work Environment Council (WEC) on obtaining the proper paperwork requested from the Board of education.
- Please inform your building administrator and head custodian about issues in your building before you call the EOEA. Trust me I will jump on it as soon as you send it to me.

- Do not try and be the custodian! We do not want any members getting injured. If something does not look right, notify office or custodian staff.
- New boilers and chillers have been either installed or are being installed as of 9-28-2020. The EOEA is waiting for certifications.

An email address.

Your NJEA personal identification number (PIN). You'll find your PIN on your membership card. Your PIN has six characters in a two-letter, two-number, two-letter combination.

What is my PIN?

You can find your PIN by logging onto njea.org with the email address you have on file with NJEA and your password. Go to njea.org and click on "Sign-in" in the upper-right-hand corner.

Enter your email address and password as directed. Your default password, unless you've changed it, is the last four digits of your Social Security number.

Once you have successfully logged on, slide over to "My NJEA" and click on "Profile."

As you scroll down, you'll see your membership card on the right-hand side. Your PIN is under your name.
