As I mentioned earlier this month, it is never too early to think about making sure all kids have access to healthy meals during the summer months. ISBE is very proud to administer the U.S. Department of Agriculture's Summer Food Service Program (SFSP) in Illinois. SFSP sponsors and meal sites across the state play a vital role in helping our children get the nutritious meals they need to be ready to learn when they return to school in the fall. ISBE is seeking more school districts, local government entities, and nonprofit organizations to help sponsor SFSP sites, as there are currently 36 counties in Illinois with no meal sites. Illinois Lieutenant Governor Evelyn Sanguinetti is an invaluable partner to the Summer Meals program and will be traveling the state over the month of February to encourage new sponsors to sign up to help end food insecurity for all Illinois children.

Our partner organizations, No Kid Hungry and the Illinois Hunger Coalition, staff a

Finally, I would like to note that Governor Bruce Rauner recently signed Senate Bill 550 into law ([Public Act 099-0922](http://PublicAct099-0922)). The Act aims to reduce children’s exposure to lead by requiring each school that serves pre-K through grade 5 students to test its water for lead. The Illinois Department of Public Health (IDPH) is mandated to administer these requirements and to provide guidance on risk management and mitigation of lead in water, and education about lead poisoning. ISBE will be sending information on IDPH’s behalf very soon.

Every child deserves the opportunity to learn in a healthy environment. I greatly appreciate your dedication to making this a reality for Illinois students.

#### **Emergency Operations Plan Train the Trainer Presentations**

Please remember that any school that operates a summer program in a building with a 50 percent or greater free and reduced-price percentage in the National School Lunch Program must serve a breakfast and/or a lunch to students in attendance.

These schools must also open their doors to children 18 and younger in the community to participate in the Seamless Summer Option or in Summer Meals, unless the regional superintendent has granted a waiver.

## **School Health Issues**

### **Interim Guidance on Safe Rat Handling in Schools**

This month the Illinois Department of Public Health (IDPH) has been notified of Seoul virus infection in eight people who handled or owned pet rats purchased from one location in Wisconsin and two locations in Illinois. States are working to identify rat breeding facilities where there may be rats with the Seoul virus and will issue updates as information becomes available.

Schools may have pet rats in the classroom. At this time, no illnesses have been reported in people linked to classroom rats. There is no recommendation to test or remove the pet rats unless you have been notified. Safe handling of pet rats, along with thorough and regular cleaning and disinfection of rat cage areas are important and should be done at all times and with all pet rats.

### **School District Annual Financial Report Review Process**

All district superintendents should have received an email broadcast asking them to review their preliminary Financial Profile Report and verify the Operating Expense per Pupil (OEPP)/Per Capita Tuition Charge (PCTC).

District administrators may submit comments regarding their district's finances that will be published along with their Financial Profile Report (500 characters max). **The comments must be submitted no later than Feb. 6.**

The email included links to the memorandum, instructions, and definitions to assist with the review process. These documents are also available in [IWAS](#) and on the [School District Financial Profile Score & OEPP/PCTC Verification Information webpage](#).

The email broadcast and Superintendent's Weekly Message will be the only notices sent to the district. If you have not received the email, please contact ISBE at (217) 785-8779. If you have given another person authority to review these reports, please forward the email to them.

It is crucial that districts review their financial profile data and score because the financial profile designation will be approved and publicly released by ISBE. Any district that wishes to include comments that support the Financial Profile Report may do so directly in [IWAS](#) beneath the report. Comments are optional, but they are encouraged; this is an opportunity for districts to explain significant financial circumstances.

It is important that you follow the instructions in completing the OEPP/PCTC verification process because once the deadline passes, changes to the 2016 Annual Financial Report data are not permitted. The deadline is Feb. 15.

The financial profile scores will be adjusted to reflect any mandated categorical aid payments due to school districts that were not paid by June 30, 2016, and not included in their FY 2016 Annual Financial Report.

## Funding and Disbursements

### New Census Estimates Released for FY 2018 Title I Low Income

The U.S. Department of Education has released the Small Area Income and Poverty Estimates (SAIPE) for income year 2015. These estimates will be used to calculate FY 2018 Title I allocations. A file of 2015 Poverty Data by Local Education Agency (LEA) is provided in an alphabetical listing of LEAs, Poverty Count, 5-17 Population, Poverty Percentage, and Total Population at <https://www.isbe.net/Pages/New-Census-Estimates-Released.aspx>

LEAs can use this data to determine their potential eligibility for Basic, Concentration, Targeted and Education Finance Incentive grants (EFIG).

**Basic Grant eligibility:** An LEA must have at least 10 poverty children and the number of poverty children must be greater than 2 percent of the LEA population of children ages 5-17.

**Concentration Grant eligibility:** An LEA must have at least 6,500 poverty children or the number of those children exceeds 15 percent of the total 5-17 population.

**Targeted Grant and EFIG qualifications:** An LEA must have at least 10 poverty children and that number must be at least 5 percent of the 5-17 population.

The following link to the Census Bureau, [www.census.gov/did/www/saipe/index.html](http://www.census.gov/did/www/saipe/index.html), provides various aspects of the SAIPE count, including the data sources and methodology used to prepare these data. We will be using the 2015 data to calculate school year 2017-18 Title I, Part A allocations because they are the most recent available data.

Superintendents, business managers, and Title I directors should carefully examine the data for their LEA as this will be the first indication as to whether your LEA may be gaining or losing in eligibility for Title I funds in FY 2018. ISBE neither controls nor generates the data. The challenge period for the 2015 estimates ends March 13, 2017. Refer to the Census Bureau link at [www.census.gov/did/www/saipe/contact/challenges.html](http://www.census.gov/did/www/saipe/contact/challenges.html), if interested.

Note that this preliminary data does not include other non-census information, such as foster, neglected, or delinquent counts that may be used to calculate Title I allocations.
