



CALL FOR PROPOSALS BE A PART OF THE CONFERENCE PROGRAM

The EGSA Fall Conference brings together the leaders and key individuals involved in on-site power to learn, network, celebrate successes and discuss the current challenges. We invite you to submit a presentation for the EGSA Fall Conference to be held in Minneapolis over the dates of September 11-13, 2022.

We want to hear your proposals. If you have a topic or case study that would bring value to our members, please submit your ideas by Monday, June 20, 2022 to Nathan Harris (N.harris@egsa.org). It will provide an exciting opportunity for you to become involved and share your knowledge.

PRESENTATION TYPES

If you are involved in the on-site power industry, we urge you to submit a proposal for one of our presentation types:

1) General Session

The Conference Committee has already secured a well-known public official to serve as the Conference Keynote Speaker during General Session #1 on Monday morning, Sept 12. We are seeking proposals for the two remaining General Sessions on Monday and Tuesday morning, Sept 12-13 and each will run approximately 50 minutes in length and scheduled prior to the morning educational sessions. **These presentations should focus on innovation, new technologies, end-users, and/or ideas that will propel the on-site power industry; the topics should apply to the industry at-large.** The General Sessions take place in the large ballroom for the entire conference audience, so we are looking for speakers that are well known in the industry and have prior experience of speaking to large crowds.

2) Educational Session

The Conference Committee is planning for nine (9) educational sessions in total split into three (3) separate concurrent timeslots on Monday and Tuesday, Sept 12-13.

Each individual session will run 45 minutes in length and will immediately be repeated after a short break so the presenter should plan to present twice over a roughly two-hour time period. **These sessions are designed for more technical topics within the industry that will help attendees gain specific knowledge to implement within their jobs and take back to their companies.**

The General and Educational Sessions should be innovative and an original program to present, share, debate, and concur on the latest practices in on-site power industry. **Please note: these sessions are not meant to be commercials for a specific company and/or product.**

3) Power Talk

Power Talks are restricted to exhibiting companies and are short 5-minute presentations. These talks will take place in the Exhibit Hall and should focus on individual company's achievements and offerings. We plan to offer up to seven (7) over Monday and Tuesday, Sept 12-13.

NOTE: Individuals can present only once but you are welcome to submit multiple topics.
