## **Social Host Ordinance**

A Community Solution to Reduce Underage Drinking

#### What is a social host ordinance?

A social host ordinance makes it unlawful for individuals (social hosts) to provide a place for underage drinking to occur on a premises under the host's control. The host is held responsible regardless of who provided the alcohol. An ordinance violation is a misdemeanor offense with a maximum penalty of 90 days in jail and/ or a \$1,000 fine.

Studies indicate that social host ordinances are among the most effective and recommended ways to reduce underage drinking.

# UNDERAGE DRINKING IN BROWN COUNTY IS LEADING TO SERIOUS HEALTH AND SAFETY CONSEQUENCES FOR EVERYONE.



According to the 2022 Minnesota Student Survey, our Brown County youth consume more alcohol and binge drink at higher rates compared to other counties in the state.


Percentage of students binge drinking (4 or more drinks in a row for females or 5 or more for males) within one setting

**63%** of students in 9th-12th grade said house parties are occurring where youth under 21 are drinking alcohol a few times a month on the weekends

### Fights, abuse, injury, illness, death

Brown County students say they have seen youth under 21 experience all of these as a result of drinking alcohol at house parties:

- ✓ Verbal or emotional abuse

## **Q&A on Social Host Ordinances**



A social host ordinance shifts the responsibility from only holding *youth* accountable, to holding *adults* accountable if they provide a place where underage drinking occurs.

# Why propose an ordinance in Brown County?

A social host ordinance reduces the harms associated with underage drinking in our community in the riskiest setting where it occurs — home parties.

Four cities in Brown County already have social host ordinances — Comfrey, New Ulm, Sleepy Eye and Springfield. The proposed ordinance would apply to the rest of the county.

#### How does a social host ordinance work?

A social host ordinance acts to deter adults from serving as social hosts for underage youth. This reduces underage drinking and the associated harms. It sends a clear message to youth and adults that the health and safety of our youth is paramount to the vitality of Brown County.

# What impact does a social host ordinance have?

A social host ordinance:

- · Helps reduce underage access to alcohol.
- Reduces the harms associated with underage drinking, including fights, abuse, injury, illness, death and more.
- Provides another tool for law enforcement to use in keeping our neighborhoods and youth safe.
- Encourages a consistent message to youth, from all caring adults in the community, about the importance of choosing not to drink alcohol before age 21.
