AGREEMENT TO TERMS

Organization affirms they are a Chugiak-Eagle River Chamber of Commerce Non-Profit Member as of July 10th, 2019.

Independent Contractor: Contractor represents and warrants that it is an independent contractor, and neither contractor nor its employees, agents or representatives shall be considered as employees or agents of the Bear Paw Festival for any purpose.

Operation Contractor: Contractor will be fully responsible for all cost of setting up, operation, moving, and providing necessary equipment and labor. There will be no availability for hookups.

Contractor shall assist in cleaning up the area utilized by contractor once their time has concluded.

Cancellation or Rescheduling of Festival: Bear Paw shall not be liable for any damages or claims of any sort whatsoever, should the Bear Paw Festival be cancelled or should its dates or hours of operation be changed, regardless of the cause for such cancellation or change.

Compliance with Laws and Standards of Operation: Contractor will comply with all applicable state, federal, and municipal laws and regulations.

Conduct of Contractor: Contractor, its agents, employees and/or operations shall be conducted in such manner as to provide a positive experience to children, families and all attendees at the Bear Paw Festival. Contractor will conduct its business in a manner consistent with the objectives of Bear Paw Festival – a family-oriented event.

Contractor agrees that all personnel on the premise will present a neat and businesslike appearance.

The Chugiak-Eagle River Chamber of Commerce nor the Municipality of Anchorage will not be responsible for damage, theft, or injury to exhibitor or their booths during the event.
