HB 1231 Insurance Claims Payments to Physicians by Black

Insurance Claims Payments to Physicians: Prohibits contracts between certain physicians & health insurers & health maintenance organizations from specifying credit card payments to physicians as only acceptable method for payments; authorizes use of electronic funds transfers by health insurers & HMOs for payments to physicians; provides notification requirements; prohibits health insurers & HMOs from charging fees for automated clearinghouse transfers as claims payments to physicians; prohibits health insurers & HMOs from denying claims subsequently submitted by physicians for procedures that were included in prior authorizations. HB 1421 Improving Screening for and Treatment of Blood Clots by Black

Improving Screening for and Treatment of Blood Clots: Requires DOH to establish, or contract to establish, statewide registry for specified purpose; requires certain licensed facilities to report specified information to department for inclusion in registry; provides that certain personal identifying information is confidential & exempt from public records requirements; requires department to exempt certain facilities from certain reporting requirements; requires certain licensed facilities to arrange for rendering of appropriate medical attention for persons at risk for certain conditions; specifies requirements for manner in which such facilities must provide such medical attention, including admission, training, & practice policies; revises requirements for certain annual inservice training for certified nursing assistants employed by nursing home facilities; revises training requirements for certain certified nursing assistants; revises minimum standards for care of residents in assisted living facilities; revises requirements for core competency test for administrators of assisted living facilities. Optometry: Revises membership requirements for Board of Optometry; revises & provides rules to be implemented by board; revises requirements for administration & prescription of ocular pharmaceutical agents & provisions related to topical & oral ocular pharmaceutical agent formularies established by board; authorizes optometrist certified in ophthalmic procedures to perform certain procedures; requires board to determine required content, grading criteria, & passing score for such examination; authorizes certain procedures certified optometrist may perform; prohibits commercial or mercantile establishment from having any control over manner in which licensee practices optometry; removes provision prohibiting surgery of any kind; authorizes specified titles & abbreviations for certified optometrists; provides requirements for advertisements; provides requirements for demonstration of financial responsibility as term of licensure. State Group Insurance Program Coverage of Standard Fertility Preservation Services: Requires DMS under state group insurance program to provide coverage of medically necessary expenses relating to standard fertility preservation services for specified policies; prohibits state-contracted HMOs & state group health insurance plans from requiring preauthorization for such services; authorizes maximum benefit provisions.
