PROBLEM & SOLUTION



The close spacing of the Allen Blvd and Denney Rd interchanges present a safety issue due to weaving and congestion. Reconfigured to a collector-distributor frontage road and eliminate Allen Blvd entrance ramp and Denney Road exit ramp.

OR217 slowing occurs due to vehicles entering and exiting mainline travel lanes for short distances. The solution is to add a continuous auxiliary lanes in southbound direction from Beaverton-Hillsdale Hwy to OR99W and in northbound direction from OR99W to Scholls Ferry Rd.

- Ramp Widening




LOCAL AGENCY PARTNERSHIP BIKE/PED SCOPE

● Pedestrian/Bike Improvements


- Extend Fanno Creek Trail along east side of OR217 to Allen Blvd (constructed by City of Beaverton, funded by ODOT)
- Widen sidewalk on north side of Denney Road from Fanno Creek Trail to 105th (extending City project, partially constructed by City of Beaverton, funded by ODOT)
- New sidewalk and bike lane on Northern Hall Blvd Overpass




SW DENNY ROAD AT FANNO CREEK OVERPASS

Existing Cross Section




Future Cross Section




SW HALL BOULEVARD (NORTH) OVERPASS

Existing Cross Section




Future Cross Section

RISK MANAGEMENT

- **Value Engineering Study** – May 2019
- **Pilot Design Exception Tracking Database** – initiated in March 2019
- **Pilot Cost Validation** – March 2020
 - Quantification of project contingency and risks
- **Cost Risk Assessment** – November 2020
 - Quantitatively modeled the identified risks with an integrated cost and schedule simulation model following Preliminary PS&E
 - Risk Register developed to manage risk – maintained throughout project


