Financial Update

Mike Isaacson Treasurer



Increasing gap between our membership revenue and operating expenses requires significant focus

- Projected deficit of \$114,000 this year, largely driven by:
 - ► Membership dues declined by \$50,000
 - ► Contributions declined by \$75,000
 - ▶ Building usage and vendor costs increased by \$35,000
 - Continued focus on safety, security, and preventive maintenance
 - ▶ JCC income continues to be a crucial source of revenue





Revenue 2022-23 Forecast: \$2,061,800






Our membership revenue is projected to decline significantly

- We currently have 536 members in good standing down 41 net households
 - Anticipating 66 member households will leave this year
 - ➤ Year to date, 23 new member households and 2 members reinstated
- ▶ 59% of our members are paying full dues, accounting for 82% of total dues revenue
- Mitzvah Appeal, Free Will, High Holy Days financial support declined by \$75,000, or 20% of prior year



Expenses 2023-24 Forecast: \$2,175,500





People costs comprise 71% of our total expenses

- Salary, benefits and related costs for clergy, administration, building, and learning total more \$1,500,000
- Projected to decrease by 12% versus last year due to staff reductions and open positions



Financial strategies moving forward

- Increased dues and fees are likely to address inflation and necessary spending
- Staff and lay leaders will focus on membership retention and attracting new members
- Increased attention to fundraising will be required
- Comprehensive leadership review of all expense and revenue components for next year's budget is underway

Beth Emet Foundation Overview

- Established in 1965, to provide financial support to the synagogue in perpetuity
- ► Comprised of various "funds" unrestricted, restricted, board-designated
- Majority of funds provide income to Beth Emet while leaving the principal untouched - a key approach to ensuring perpetual support
- Managed by a nine-person board elected by the Beth Emet Board of Trustees for 3-year (staggered) terms and are limited to 3 consecutive terms
- ► Foundation Board Members:

Three General Categories of Funds

Unrestricted - Fundraising Campaigns / General Donations

- Assuring Our Future Fund (1986; 2001)
- Rabbi Peter and Elaine Knobel Fund (2010)
- T'rumah Campaign Fund (2017)
- Dor L'Dor Bequests (go into Assuring Our Future Fund)
- General Contributions (typically unrestricted)

Restricted - Donor Designated

- Memorial Funds (e.g. Cohen; Sherwin; Chiss)
- Social Justice (e.g. Huckman)
- ► Education/Youth (e.g. Kaufmann; Perlman; Polk)



Managing the Funds

- ► Each fund is managed by a covenant or policy that directs how the principal and income can be used
- Most covenants place restrictions on the use of principal and only allow "income" to be distributed, ensuring perpetual support
- ► To smooth out year-to-year volatility and provide for consistency of distributions, income generated by the funds is generally defined to be 4%-5% of the average trailing three years' balance
- ► 4%-5% is consistent with the long-term expected return over time of a 60%/40% stock/bond investment portfolio

Beth Emet Foundation Balances as of December 31, 2022



- ► Total assets of \$5.2 million, including \$1.5 million of contributions from the T'rumah Capital Campaign
 - Income generated from Unrestricted Funds is distributed each year to support Beth Emet's annual operating budget
 - Unrestricted and Board-Designated income distributions this fiscal year total \$197k
- ► \$45k in distributions from Restricted Funds to Beth Emet operations in last fiscal year
- Dor L'Dor Impact: The Foundation has received \$385,000 in Dor L'Dor bequests since January of 2021



Beth Emet Foundtaion Investment Allocation and Balances


The Foundation's investment portfolio is comprised of a low-cost (13 bp) Vanguard LifeStrategy Moderate Growth Fund which has the following investment allocation:
