The ACC application expires if work is not started within six months of ACC approval. Projects in violation of the ACC approval may be fined up to \$150 and may be required to remove any changes.

The Fifth Amendment to Declaration of Covenants, Conditions, and Restrictions for Sonoma Verde Rockwall County, Texas filed of record on April 7, 2021, allows the Association to charge a fee for the initial review and first appeal, if applicable. A copy of the Amendment is posted on the community website under "Resources", "Community Documents". The application fee directly off sets the cost of the third party review of applications by an Architectural/Engineering firm.

Approved ACC applications must be initiated within 6 months or resubmission is required. Projects extended more than 1 month after approved completion date will require an extension review.

Fences cannot obstruct the flow of surface water or water in any drainage easement. Maintenance of homeowner's property outside the fence is the responsibility of the homeowner.
