Fees Per Event: \$40 – If you are accepted your check will be due February 26, 2026.

Rain or Shine

Electricity: Electricity will be provided if inside. If setting up outside, please make sure to bring an extension cord and tape to secure it.

Set Up/Breakdown: You will be allowed to set up at 7:30 AM. Doors open at 9:00 AM

You must wait until the event ends at 3:00 PM to breakdown. Please ensure you clean up your area and take all your trash with you when you leave.

Important Reminders

- Vendors are encouraged to carry their own liability insurance. The Caroline County Chamber of Commerce, Caroline County 4-H Park, and Big Bass USA are not responsible for any damage to any part of your booth or your merchandise. Vendors are fully responsible for protection of their property and for securing their displays. You are solely responsible for any injuries, accidents, or losses which may be sustained as a result of your vending operations at The Fishing/Kayak Expo 2026. If accepted you will receive confirmation from the Chamber or Big Bass USA.

- You are responsible for your staff, and all vendors must conduct themselves in a courteous, polite and professional manner. All vendors must abide by the rules & regulations of the Caroline County Chamber of Commerce's Fishing/Kayak Expo 2026.
