Read, initial, and Sign Parade Rules and Regulations

1. Children under the age of 8 may ride, but are not allowed to march in the parade unless individually accompanied by an adult and all children under the age of 18 must be accompanied and directly supervised by an adult at all times.
2. Drinking of alcohol or consuming illegal substances by parade participants is not permitted at any time during the parade or its formation.
3. As a safety precaution, no candy or other objects shall be thrown in any way by Parade Groups. No items may be handed out from any area of Parade route.
4. Each Parade Group is REQUIRED to have general liability insurance and each group using a vehicle in the parade shall ensure that all such vehicles are insured as required by Rhode Island Law and a copy provided with the completed application. Commercial Vehicles should have no less than \$1M combined single limit.
5. Each Parade Group agrees to defend, indemnify and hold harmless the Town of Smithfield and the Smithfield Public Schools against all claims, suits or demands arising out of the fault or conduct of the Parade Group.
6. Parade applicants shall clearly identify a person or persons in charge of their Parade Group who may be contacted by Parade officials regarding parade rules violations.
7. Groups must march in their assigned spots.
8. If you and/or your vehicle will be staying for the tree lighting ceremony, parking will be available at end of route. If you will be leaving, please continue down Smith Ave for departure.
