The application must include **ALL** of the following information and supporting documents:

1. A **typed essay** about your organization. Tell us your story in 1 page. Who are your leaders, your staff members, your board members? Why do you exist? Who do you serve? What are your challenges?
2. A **1-page statement** identifying your request, the amount of your request, how you would use the money, and how it would help move your organization forward.
3. A copy of your **annual report** or **most recent IRS Form 990**, **your most recent financial statements**, and your **annual budget**.

All information on this application shall be kept confidential. Please don't submit collateral or promotional materials.

Funds must be spent within 12 months of receipt. When funds are spent, we request **a report on how you spent the money**, and the **benefit it provided**.

We **do not fund** political organizations nor their activities, religious denominations, for-profit organizations or their activities.
