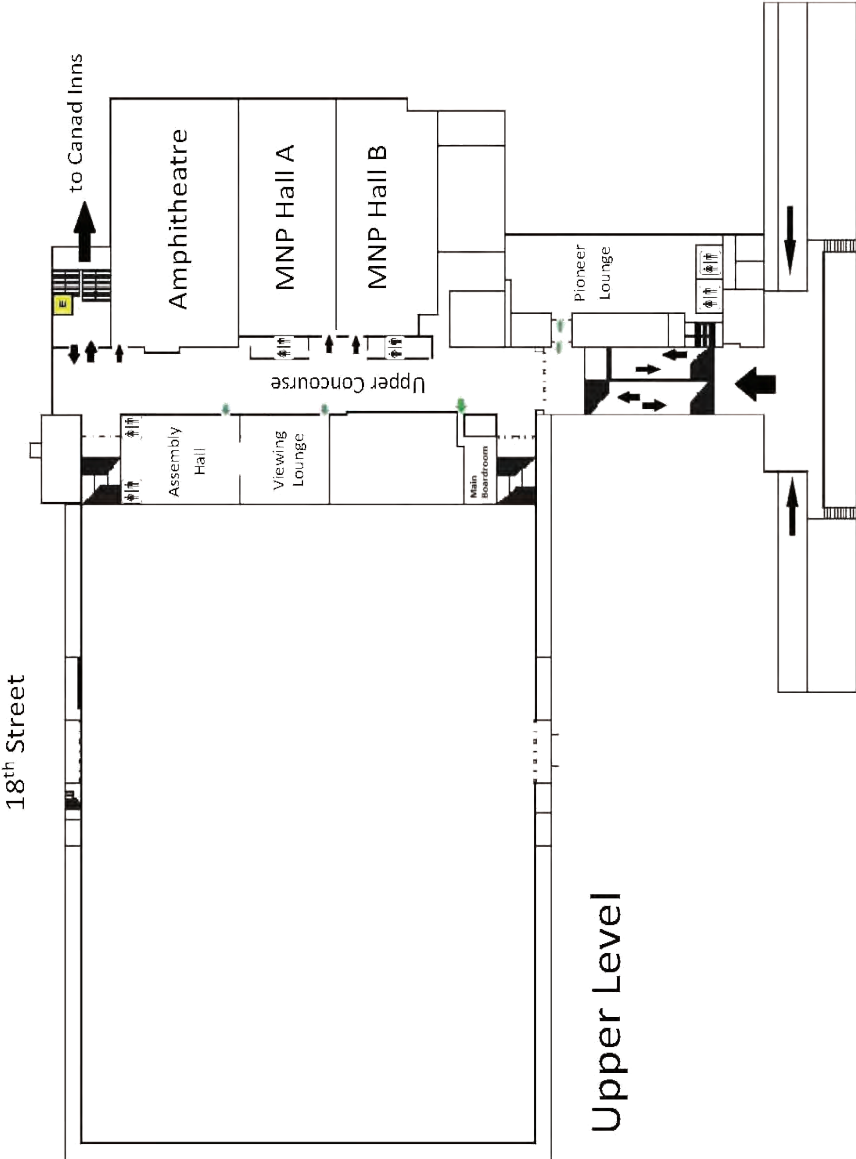

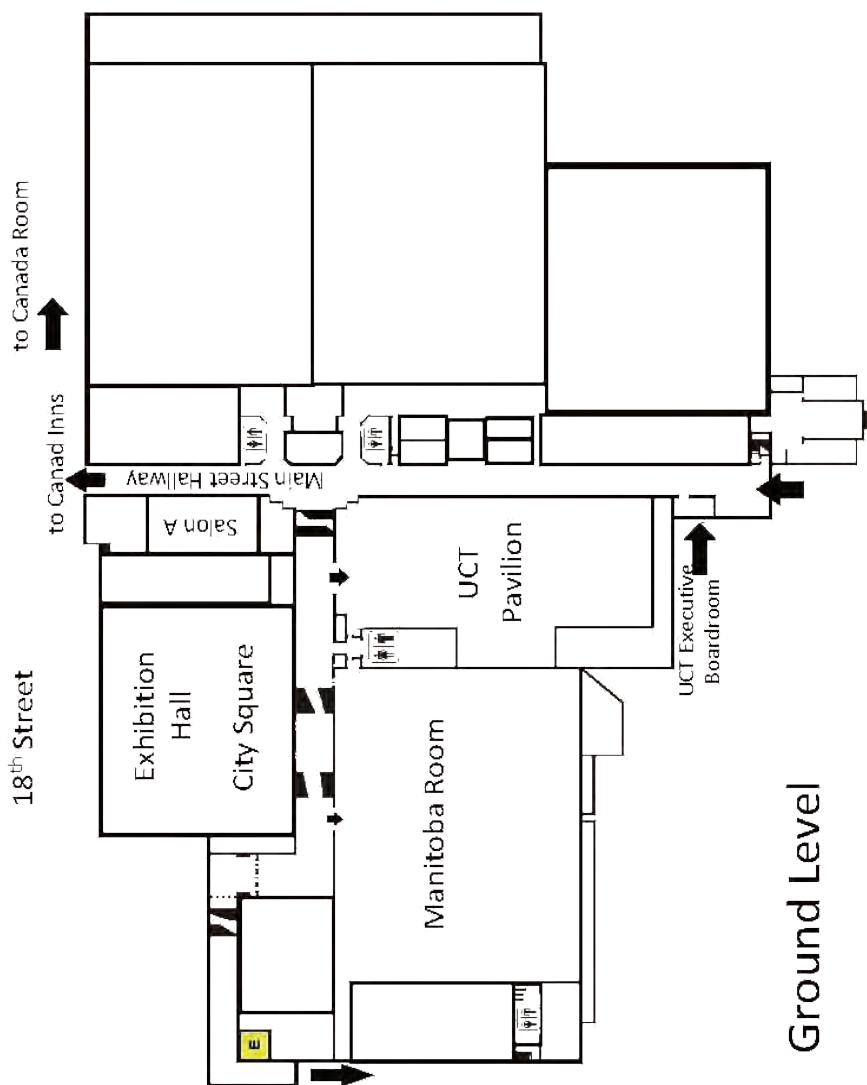

# Honourary Life Member



## Drew Caldwell

Born and raised in Brandon, Drew began his municipal career in 1992 when he was elected city councillor for historic downtown Rosser Ward. He was returned to city council three times before commencing a seventeen-year run as MLA for Brandon East. During his time on Brandon city council, Drew established a reputation as an activist politician, leading successful initiatives to restore low density residential zoning to his ward, develop a commercial core business improvement area and “green” the streets of Downtown Brandon. He was also very active in initiatives promoting heritage preservation, the environment, public health and poverty reduction in Brandon.

In 1997-98, Drew was elected to the provincial boards of both the Manitoba Association of Urban Municipalities and the Union of Manitoba Municipalities, commencing a passion for advancing municipal leadership in Manitoba politics. Drew served on the joint committee tasked with amalgamating these two municipal organizations and, at the conclusion of this work, was a founding director of the newly constituted Association of Manitoba Municipalities.

In 1999, Drew was elected to the Manitoba Legislature and was appointed to cabinet by Premier Gary Doer as the new government’s first Minister of Education. He subsequently held the positions of Minister of Family Services and Housing, as well as Minister of Municipal Government with responsibility for the City of Winnipeg and the Building Canada-Manitoba Infrastructure Fund. Drew also served as Legislative Assistant to both Premier Gary Doer and Premier Greg Selinger and was a member of Treasury Board.

As Minister of Family Services, Drew was of paramount importance in securing a decades-long held municipal objective of creating a single-tier social assistance program for the Province of Manitoba. During his time as Minister of Municipal Government, it was his greatest privilege to personally shepherd vital municipal infrastructure projects through Treasury Board and Cabinet. As a builder and an activist, helping municipalities achieve important community development objectives was immensely satisfying for him.

Since leaving electoral politics in 2016, Drew has divided his time between homes in Manitoba and Quebec. He remains a strong advocate for and supporter of the Association of Manitoba Municipalities.

## Randy Sigurdson

After completing University in Winnipeg, Randy Sigurdson began his teaching career at the Gimli High School. During this time he met Heather and they began their life together as husband and wife in 1973.

The rest of Randy's teaching career was in Arborg. As the years went by involvement in community affairs was part of town life. Curling kept the Sigurdsons active in the winter and Randy was a board member and President of the club for many years. Over time priorities changed and involvement in their children's activities took precedence.

Prior to the 1995 municipal election the Arborg mayor at the time asked Randy to let his name stand as a councillor.

Randy didn't know what it all entailed but never regretted the decision, serving on the Arborg town council for 24 years, 16 of those as Mayor.

Being in public life was very rewarding. The councils and staff Randy had the pleasure to work with were exemplary. The community itself was always supportive of council decisions however tough they may have been. Randy believes his time in municipal government would have been much shorter without these good people.

Serving as an Interlake Director on the AMM board was certainly another highlight of his career. Being part of this enabled Randy to see the issues from a different perspective and he met some interesting characters over the years and made some good friends. He enjoyed the many committees he served on such as Doctor Recruitment at Manitoba Health and the Disaster Assistance Appeal Board—important work and very rewarding.

Randy appreciates the good people at the AMM office and the professionalism that is always practiced. It is not an easy job to do everything they do for the municipal governments but seeing it first hand gives an added appreciation of its inner workings.

## **Cyber Security is Good Business**

In June 2018, the Manitoba government passed The Sustainable Watersheds Act which amends four pieces of legislation including The Water Rights Act. The Water Rights Act governs drainage and water retention in Manitoba. In October 2019, the Manitoba government passed new regulations supporting a new streamlined approach to drainage licensing through a new registration process as well as enhanced protection of wetlands through a no net loss of wetland benefits approach to water management in Manitoba. This presentation will provide an update on changes to the Water Rights Regulation and an overview of the new authorization process and online application system.

When her injuries barred her from service, she fought a policy that excluded women—a historic victory for female military members.

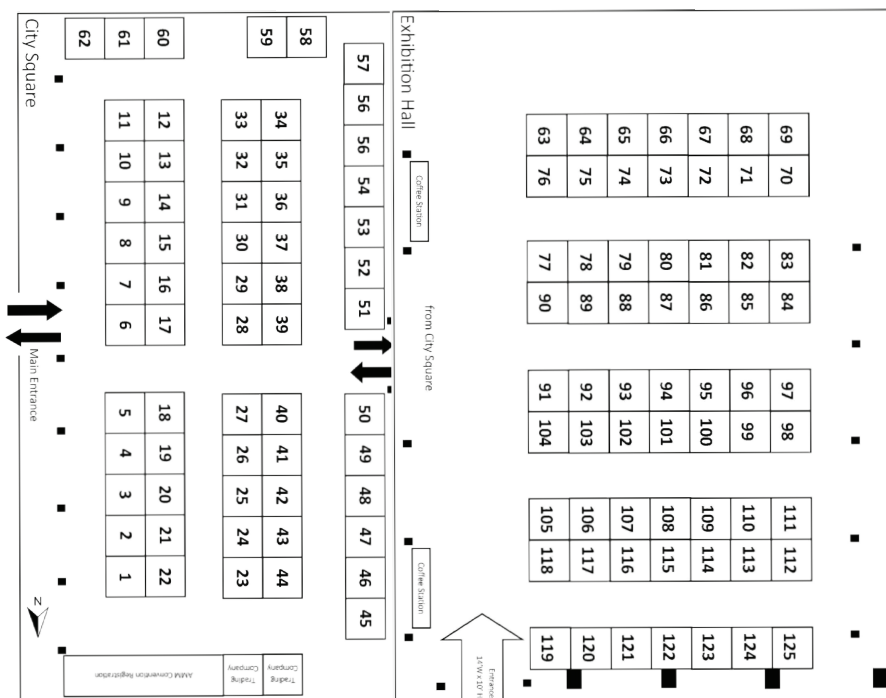

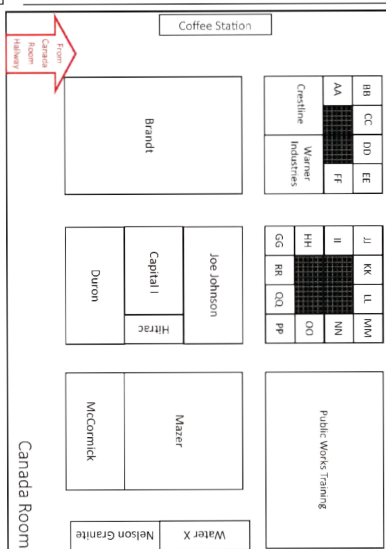

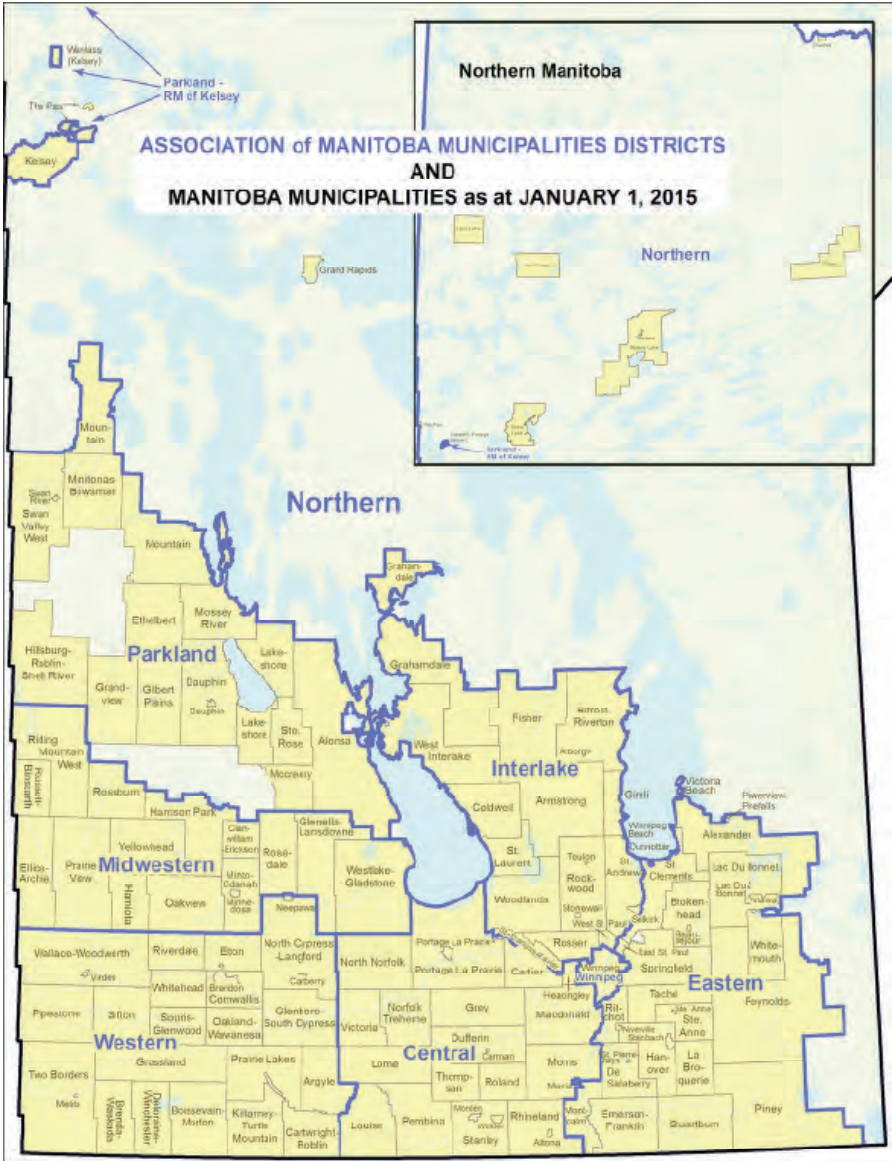

1. Members of the Resolutions Committee will read out the operative clauses of a given resolution - i.e., the resolved portion.
2. The Chair will move the resolution.
3. The Chair will call for a seconder who will second the resolution by providing their name and municipality.
4. The seconder will open debate on the resolution. Then any municipal official is welcome to speak in favour or opposition to the resolution at hand; microphones will be labelled specifically for those "in favour" and "opposed".
5. Anyone speaking to a resolution will have a maximum of two minutes. The time remaining for speakers will be displayed, counting from two minutes to zero, at which time microphones will be turned off.
6. As provided for in Robert's Rules of Order, the Chair will call for speakers alternately from each microphone position. If no speakers with an alternate position request the floor, the Chair may, after entertaining three or more speakers to the one position, end debate even if further speakers to the position have already requested the floor.
7. No one may speak twice per resolution unless for clarification.
8. The seconder will be invited to close debate.
9. Amendments to motions may be introduced by any registered voting delegate. Unlike the "Standing Order" for main motions, the Chair will not move an amendment.
10. Once the motion to amend has been introduced, the Chair will decide if the amendment is in order (i.e., does not change the intent of the motion).
11. If the Chair decides the motion is in order, they will call for a seconder.
12. Once the amendment has been moved and seconded, the motion to amend will be dealt with in the same way as all motions as outlined in the Standing Orders and Rules of Order.
13. Unlike main motions, however, amendments to the amendment will not be accepted.
14. Discussion on an amendment must address the amendment only and not the merits of the main motion.
15. The Chair will entertain only two amendments per resolution.
16. Should more than two amendments come forward, the Chair may send the resolution to the Resolutions Committee and the Parliamentarian for their consideration.
17. The decision of the Chair is final.

## DEBATING STANDING POLICY RESOLUTIONS

- A delegate wishing to debate a Standing Policy resolution must move a motion asking the Chair to "suspend the rules".
- If there is a seconder, the Chair will ask for the vote on the motion. The motion passes if 2/3 of delegates vote in favour of it.
- If the motion is passed, the remainder of the debate follows the normal resolution process.

# Resolution Categories

## RESOLUTION CATEGORIES

The following categories shall apply to all resolutions submitted for consideration by the Association of Manitoba Municipalities at either the Annual Convention or the District Meetings.

### CATEGORY 1: MUNICIPAL ISSUES

Category 1 resolutions are resolutions whose outcome has the potential to impact a majority of municipalities.

It is possible that the outcome of a Category 1 resolution might not immediately impact all municipalities, but the outcome has the potential to impact a majority of municipalities. This impact may be direct or indirect.

Examples of areas of influence of Category 1 resolutions include direct changes to legislation that govern municipalities, such as *The Municipal Act*, or more indirect changes to government programs that might impact municipalities, like a change in the provincial drainage program.

Category 1 resolutions, if passed at the District Meetings, will be brought forward to the main Resolutions Committee for consideration at the Annual Convention.

### CATEGORY 2: LOCAL OR REGIONAL MUNICIPAL ISSUES

Category 2 resolutions deal with local or regional issues that affect one region or only a small number of municipal governments.

An example of a Category 2 resolution would be a resolution dealing with a necessary improvement to a specific local road.

Resolutions in this grouping will be presented at the District Meetings; however, they will not be submitted for consideration at the annual Convention. A resolution in this category, if passed at the District Meeting, will be dealt with by the Board of Directors as they see fit.

### CATEGORY 3: NON-MUNICIPAL ISSUES

Non-municipal issues do not affect municipal governments.

Resolutions in this grouping will not be presented at the District Meetings or the Annual Convention; instead, they will be dealt with by the Board of Directors as they see fit.

## By-Law 2019

Currently, as worded, Article 5 of By-law 1998 permits nominees to accept nominations for the position of President and a Vice-President position at the same time. It is proposed that Executive Committee nominees can only accept a nomination for either the President position or a Vice-President position, and not for both.

Be it resolved that the following change to By-law 1998 is therefore approved:

- (1) The following sentence is added after the last sentence in Section 2 of Article 5  
  
“Nominees can only accept nomination for one position, that is, for the position of President or for a Vice-President position, not both.”
- (2) This amendment is effective immediately after the 2019 annual convention.

WHEREAS things have evolved over the past 20 years and we now have 137 municipalities; and

WHEREAS AMM had undertaken a major, cross-Canada review of board structure and size with similar organizations like AMM that indicated the AMM board structure and size may need to be reduced in comparison to other associations;

**Therefore Be It Resolved That**

the AMM review the report they commissioned and make a recommendation to the membership regarding board structure and size at the 2019 Convention.

**NOTE: The AMM Board of Directors recommends maintaining the current board structure and size.**

WHEREAS Canadian-produced oil should be given a priority over oil imported from other countries; and

WHEREAS it is desirous to have Canadian oil transported via pipeline to the East Coast, and exported to markets overseas for the economic benefit of all Canadians;

WHEREAS the Manitoba Bureau of Statistics (MBS) reported that Manitoba's Consumer Price Index increased by 1.3% in 2016, 1.6% in 2017, 2.5% in 2018, and in April 2019 was ranked as the second highest in Canada at 2.3%; and

WHEREAS there are some municipalities within Manitoba that would like to have some flexibility in determining what the portioning percentages should be;

#### Therefore Be It Resolved That

the AMM lobby the Province of Manitoba to amend Regulation 184/98 to reflect a 5% variation either above or below the current portioning percentages; and

WHEREAS the full disclosure of information will determine that the existing distribution model is not fair and equitable;

**Therefore Be It Resolved That**

the AMM lobby the Province of Manitoba to review the existing per capita model of VLT distribution and provide the results to all municipalities; and

FURTHER BE IT RESOLVED THAT the Province of Manitoba develop a new model for VLT distribution based on a percentage of VLT revenue by municipality, in order to assist municipalities in addressing and mitigating the social problems created as a result of the VLT revenues leaving municipalities; and

FURTHER BE IT RESOLVED THAT the Province of Manitoba dedicate a larger percentage of VLT revenue to support provincial programs addressing social issues created through the use of VLTs.



## AMM Resolution #11-2019

WHEREAS some municipalities have been exempt from paying taxes on their assets in other municipalities;

**Therefore Be It Resolved That**

the AMM lobby the Province of Manitoba to end all exemptions, beginning with inter-municipal, and oblige all Grants-in-Lieu to be paid at the rate of 100% (except provincial departmental roads), including City of Winnipeg, GWWD, and unimproved Crown lands accessible by municipal all-weather roads by 2024.

## AMM Resolution #12-2019

### Depoliticizing Municipal Fees and Charges

WHEREAS Section 232 subsection 2 of *The Municipal Act* empowers municipalities with the ability to “establish fees or other charges for services, activities or things provided or done by the municipality or for the use of property under the ownership, direction, management or control of the municipality”; and

WHEREAS this section is generally interpreted to mean that such fees and charges may only be levied through a by-law passed by Council and as such cannot be delegated to administration; and

WHEREAS today’s municipalities offer a wide range of products and services the cost of which are often linked to market prices which may change frequently; and

WHEREAS the inability to delegate the setting of some fees and charges to administration creates bureaucratic red tape and makes it onerous to keep municipal fees and charges in line with the market place where appropriate; and

WHEREAS requiring municipal Councils to vote on every fee and charge implemented by the municipality politicizes these decisions and discourages keeping fees and charges in line with the costs incurred; and

WHEREAS municipal Councils could effectively regulate and oversee the setting of fees and charges through resolutions and policy rather than prescriptive and slow-reacting by-laws;

**Therefore Be It Resolved That**

the AMM lobby the Province of Manitoba to amend *The Municipal Act* to give municipal Councils the ability to set fees and charges through mechanisms other than by-law.

## AMM Resolution #13-2019

### The Planning Act

WHEREAS when a public hearing has been held under *The Planning Act* and a decision has not been made before a municipal election, newly-elected officials who were not a member of Council and therefore did not participate in the hearing are unable to participate in Council's decision-making despite being knowledgeable and taking the time to become informed about the application and issues; and

WHEREAS a newly-elected official should have the ability to participate in the decision where the official reviews all material filed in the application and the minutes of the public hearing; and

WHEREAS this change would allow for greater participation by elected officials on matters of importance in their communities.

**Therefore Be It Resolved That**

the AMM lobby the Province of Manitoba to amend *The Planning Act* to provide for newly-elected officials to be allowed to participate in Council decision-making for applications where a public hearing has been held under *The Planning Act* before the municipal election but no decision has been made, if the official informs themselves about the application by reviewing all material filed in the application and the minutes.

## AMM Resolution #14-2019

### Tax Sale Administration Fee Increase

WHEREAS Regulation Number 50/97 is a regulation under *The Municipal Act* which prescribes fees, discounts and penalties which municipalities may provide or charge their ratepayers; and

WHEREAS this Regulation sets the maximum fee for the administration of a Tax Sale, being \$50.00; and

WHEREAS this fee is no longer an accurate reflection of the work and costs bore by the municipality in administering a Tax Sale;

**Therefore Be It Resolved That**

the AMM lobby the Province of Manitoba to update Regulation 50/97 under *The Municipal Act* to provide for an administration fee for tax sales that is suitable to the costs and work involved in administering a Tax Sale.

## AMM Resolution #15-2019

### Tax Sale Penalties

WHEREAS there is no penalty to any land owner for allowing their property to be sold through a Municipal Tax Sale; and

WHEREAS if a property owner's credit score was affected by letting these parcels of land go through the Tax Sale it would deter many from giving up certain lands and decrease the amount of costs bore by the municipality;

**Therefore Be It Resolved That**

the AMM lobby the Province of Manitoba to make adjustments to *The Municipal Act*, specifically Division 6 in regards to Tax Sales of Real Property, to make provisions so those persons who allow their property to be sold at a Municipal Tax Sale will have such registered against their credit score.

## AMM Resolution #16-2019 - WITHDRAWN

### ATV Use of Municipal Road

WHEREAS the RM of Hanover has seen a significant increase in the number of ATVs; and

WHEREAS these ATVs are required to use municipal ditches to travel from one place to another; and

WHEREAS the use of ATVs in municipal ditches negatively affects the drainage system in the municipality costing the ratepayers of Hanover tens of thousands of dollars in repairs annually; and

WHEREAS the Province of Ontario and several US States have legislation permitting ATVs to use municipal roadways when properly registered and equipped with the required signal lights and horn; and

WHEREAS the use of ATVs on a well-maintained municipal road will provide an increased level of safety for ATV users;

**Therefore Be It Resolved That**

the AMM lobby the Province of Manitoba to amend legislation to permit ATV use on municipal roads similar to provincial legislation in the Province of Ontario and several US States.

## AMM Resolution #17-2019

### Municipal Election Offences

WHEREAS currently a complaint regarding an offence committed under *The Municipal Councils and School Boards Election Act* must be made to the RCMP who will decide whether to investigate and prosecute the complaint; and

WHEREAS for an election finance offence under *The Municipal Act*, the municipality's chief administrative officer is involved in the investigation of the offence, with the decision on whether to prosecute made by municipal Council or by the RCMP if the complaint is made to the RCMP; and

WHEREAS Chief Administrative Officers and municipal Councils are not trained, nor do their duties fit with the investigation and prosecution of election offences; and

WHEREAS by contrast, the enforcement system available for provincial election offences is carried out by a trained, independent, and accountable system in accordance with *The Elections Act* and *The Election Financing Act*; and

WHEREAS investigation and enforcement for provincial election offences are carried out under the direction of the Commissioner of Elections, appointed by the Chief Electoral Officer of Manitoba;

**Therefore Be It Resolved That**

the AMM lobby the Province of Manitoba to amend *The Municipal Councils and School Boards Election Act* and *The Municipal Act* to provide for a coordinated approach to the enforcement of municipal election offences, to be achieved by either having Elections Manitoba's Commissioner or a separately created Commissioner of elections for municipal elections, responsible for the enforcement of municipal election offences.

## AMM Resolution #18-2019

### The Mental Health Act

WHEREAS under Section 15(1) of *The Mental Health Act* a peace officer who takes a person into custody for an involuntary medical examination under Section 11 or 12 or an involuntary psychiatric assessment under Section 9 shall remain with the person and retain custody of them, or arrange for another peace officer to do so, until the examination or assessment is completed or the person is admitted to the facility; and

WHEREAS *The Mental Health Act* is amended under *The Mental Health Amendment Act* in: Sub-Section 15(1) by adding “or a qualified person” after “for another peace officer”; after Sub-Section 15(3) by adding: Sub-Section 15(4) in this section, “qualified person” means a person who holds a position specified in the regulations or who has received training specified in the regulations; and

WHEREAS peace officers are taken away from regular duty for extended periods of time, leaving their municipalities exposed to greater risk and public safety issues when they are not available; and

WHEREAS in addition to public safety issues, significant overtime costs are incurred by municipalities;

#### Therefore Be It Resolved That

the AMM lobby the Province of Manitoba to:

- expedite the implementation of “qualified persons” at healthcare facilities; and
- provide a safe and secure area at a healthcare facility for persons in custody while awaiting examination and/or assessment.

WHEREAS there are insufficient resources for education regarding meth, insufficient supports for those addicted and their families, and insufficient resources to enforce laws regarding the crimes related to meth; and

WHEREAS many of the effects of meth use present indirect and direct costs to municipalities;

**Therefore Be It Resolved That**

the AMM lobby the Province of Manitoba to provide sufficient funding to educate the population regarding the hazards of the use of methamphetamines in hopes to prevent its use, provide sufficient funding for readily available and comprehensive rehabilitation programs for those addicted, and sufficient funding for law enforcement associated with the crimes related to the distribution of meth.

### Proceeds of Crime

WHEREAS criminal property forfeiture (proceeds of crime) is a civil court process through which the government may apply to confiscate property or proceeds of unlawful activity and property used in committing crimes; and

WHEREAS *The Criminal Property Forfeiture Act* allows the director of the unit to start civil forfeiture proceedings against property believed to be the proceeds or instruments of unlawful activity; and

WHEREAS a judge of the Court of Queen's Bench decides whether to order forfeiture; and

WHEREAS in 2012 *The Criminal Property Forfeiture Act* was amended to allow a simpler process known as administrative forfeiture through which personal property valued at \$75,000 or less may be confiscated without involving the courts; and

WHEREAS proceeds of confiscated property are deposited in the Criminal Property Forfeiture Fund and managed or distributed as provided for in section 19 of *The Criminal Property Forfeiture Act*, uses include operating expenses, victim compensation and programs promoting safer communities; and

WHEREAS none of the revenue general from criminal property forfeiture goes to government. The legislation governing criminal property forfeiture requires all unspent money to stay in a trust fund which provides a sustainable source of funding for future compensation to victims of crime or to be invested in safe communities' initiatives; and

WHEREAS the Province of Manitoba asks police services to submit applications under the Criminal Property Forfeiture Grant for funding for projects that enhance the practices and training of law enforcement agencies, or reduce or prevent crime; and

WHEREAS through this grant funding, the proceeds of crime do not necessarily go back to the municipality that crime originated in.

**Therefore Be It Resolved That**

the AMM lobby the Province of Manitoba to ensure the proceeds of crime are dispersed automatically to the community that was directly affected by the crime and the proceeds were obtained from without having to make an application.

WHEREAS *The Fires Prevention and Emergency Response Act* states that no action or proceeding may be brought against the fire commissioner, a designate or any other person acting under the authority of the *Act* for anything done or not done, or for any neglect in the performance or intended performance of a duty under this *Act* or regulation or in the exercise or intended exercise of a power under this *Act* or regulation; and

WHEREAS the wording of the legislation is not firm enough to address the issue of volunteer firefighters being individually named in proceedings while carrying out their duties for the municipality; and

WHEREAS naming individual volunteer members in litigation as a result of duties performed will most certainly have a negative impact on volunteers wanting to continue providing these volunteer services; and

WHEREAS the Province of Saskatchewan's *Fire Safety Act* is very specific in detail as it relates to immunity from liability of firefighters and volunteers;

**Therefore Be It Resolved That**

the AMM lobby the Province of Manitoba to make changes to *The Fires Prevention and Emergency Response Act* which would provide immunity from liability for firefighters and volunteers performing duties on behalf of Manitoba communities when providing fire services; and

FURTHER BE IT RESOLVED THAT the changes also include action or proceedings against a local authority for any loss, injury or damage suffered by reason of anything in good faith done, caused, permitted or authorized to be done while performing fire protection services.

WHEREAS provisions in *The Mining Tax Act* only addresses monies in excess of \$10,000,000 and does not identify how the balance of funds can be accessed by mining communities; and

WHEREAS mining communities are being negatively impacted by prolonged periods of low commodity prices and global market pressures and need meaningful access to the MCRF to mitigate the negative impacts on their communities which will benefit Manitoba as a whole; and

WHEREAS the Province of Manitoba needs to amend *The Mining Tax Act* to adequately and proactively facilitate the access of necessary funding by mining communities in their time of need pursuant to the mandate of the MCRF;

**Therefore Be It Resolved That**

the AMM lobby the Province of Manitoba to amend *The Mining Tax Act* to:

- Increase the percentage of mining tax that they allocate to the MCRF to ensure the fund remains sustainable and viable to support mining communities;

- Clarify the process for mining communities to access the MCRF below the \$10,000,000 value;
- Support the economic diversification activities of mining communities to ensure their long-term sustainability; and

WHEREAS CEDF has provided over \$136 million dollars in developmental business loans between 1972 and 2017, resulting in the creation of 7,277 jobs in the Province of Manitoba; and

WHEREAS \$988 million dollars in business revenues were generated, and \$243 million dollars in wages were paid out in the period of 1999-2018 as a result of CEDF development business loans, contributing greatly to the economic development of local economies in Manitoba; and

WHEREAS the raw water quality of Lake Winnipeg has deteriorated significantly over the past several decades and continues to deteriorate at an exponential rate that will inevitably result in the 'death of the lake' with dire consequences for all stakeholders unless there is timely intervention from all three levels of government; and

WHEREAS the high levels of phosphorus in Lake Winnipeg are a significant contributing factor to the increased frequency and severity of algae blooms developing along many beaches during the summer season; and

WHEREAS the City of Winnipeg is discharging sewage that contains high levels of phosphorus that do not meet its provincial operating license increasing the nutrient load and further exacerbating the deterioration of the raw Lake Winnipeg water quality; and

WHEREAS the City of Winnipeg's decision to reject the Lake Winnipeg Foundation and International Institute for Sustainable Development's proposal to use ferric chloride to reduce the substantial amount of phosphorus being dumped into Lake Winnipeg by up to 70% will result in the continued discharge of high levels of phosphorus by the City into Lake Winnipeg; and

WHEREAS Lake Winnipeg is of vital importance to all stakeholders including indigenous peoples, fishers, cottagers, residents, as well as communities that use the lake as a source of economic growth or stability, and many other user groups who are presently negatively impacted by the unacceptable and unsustainable condition of the lake;

the AMM to strongly urge the City of Winnipeg to immediately reconsider the Lake Winnipeg Foundation and International Institute for Sustainable Development's proposal to use ferric chloride to substantially reduce the amount of phosphorus being discharged into Lake Winnipeg; and

WHEREAS in 2012, it was estimated that the national average of organic waste diversion was 72 kilograms per person, but the Manitoba average of organic waste diversion was only 20 kilograms per person per year; and

WHEREAS the Province of Manitoba recognized the importance of organic waste diversion and set a goal, increasing the diversion rate to 100,000 tonnes or approximately 82 kilograms per person per year; and

WHEREAS in 2015, the total of reported organics diversion for registered Manitoba Compost Support Program Facilities was only 48,000 tonne or only 48% of the provincial goal; and

WHEREAS communities across Manitoba recognize the importance of composting and would like to establish community composting programs, but due to red tape and the prohibitive costs associated with meeting environmental regulations is not attainable; and

WHEREAS the benefit of the reduction in red tape and the environmental requirements associated with establishing community compost programs would assist the Province of Manitoba to meet its organic waste diversion rate goal and would allow municipalities the ability manage more effectively the organic material entering its Solid Waste Landfill Sites;

the AMM lobby the Province of Manitoba to review its process for licensing community composting sites and amending the process and requirements that would be financially and operationally attainable for municipalities.

WHEREAS the affected municipalities were led to believe the CBP was likely going to be implemented and available to the municipalities affected by the Manitoba-Minnesota Transmission Line; and

WHEREAS the six affected municipalities received notice on February 4, 2019 that there was a change in policy direction and that CBP funding would no longer be available for the Manitoba-Minnesota Transmission Line due to a broad government policy change; and

WHEREAS the provincial government has indicated that Manitoba Hydro will not pay CBP funding when there aren’t any adverse effects, such as health and safety risks; and

WHEREAS the affected municipalities see significant adverse effects including road damage, lower assessment values, increased risk of disasters such as wildland fires, decreased economic viability for land development and reduced agricultural viability from the construction and ongoing maintenance of the line; and

THEREFORE BE IT RESOLVED THAT the AMM lobby the Province of Manitoba to remove the requirement from the Police Services Act for an area with a population between 750 and 1,000 formerly designated as an urban municipality to provide policing services.
