# **Keynote Address: Babies of Technology: Assisted Reproduction and the Rights of the Child**

Alarmingly, scarce attention has been paid to the lax regulations that have made the U.S. a major fertility tourism destination. Without clear protections, the unique rights and needs of the children of assisted reproduction are often ignored. This talk will consider the voice of the child in discussions about regulating the fertility industry. The controversies are many. Donor anonymity is preventing millions of children from knowing their genetic origins. Fertility clinics are marketing genetically enhanced babies. Career women are saving their eggs for later in life. And women in developing nations are renting their wombs to the rich. Meanwhile, the unregulated fertility market charges forward as a multi-billion-dollar industry.

## **Keynote Address: Reproductive Health Services in the United States**

Dr. Joffe will describe the situation of reproductive health services in the U.S. as being one of unwanted, coercive services imposed on certain populations: e.g., forced sterilizations on Latinas, African Americans and poor whites, contraceptive services disproportionately located in African American neighborhoods at the beginnings of Title X, the national family planning program, and at other historical periods, such as the present, insufficient publicly provided services for these same populations.
