# Child Care Facility COVID 19 Health and Safety (H&S) Plan

- Each child care facility must create a COVID-19 H&S Plan which will serve as the guidelines for facility's COVID-19 child care activities.
- The COVID-19 H&S Plan should be tailored to the unique needs of each facility and should be created in consultation of guidance and policy issued by OCDEL, DOH, and comply with CDC guidelines.
- Each plan should incorporate enough flexibility to adapt to changing conditions.





# Health and Safety Plan Template



## Child Care Facility COVID 19 Health and Safety Plan Template

Each child care facility must create a COVID-19 Health and Safety Plan which will serve as the guidelines for the facility's child care activities. As with all emergency plans, the COVID-19 Health and Safety Plan developed for each child care facility is tailored to the unique needs of each facility and should be created in consultation of guidance and policy issued by Office of Child Development and Early Learning (OCDEL), Pennsylvania Department of Health (DOH), and comply with the Centers for Disease Control and Prevention (CDC) guidelines. Given the dynamic nature of the pandemic, each plan should incorporate flexibility to adapt to changing conditions. The templates provided in this toolkit can be used to document a facility's COVID-19 Health and Safety Plan, with a focus on training and communications, to ensure all stakeholders are fully informed and prepared for phased-in reopening or continuing to operate with a waiver during COVID-19. OCDEL recognizes that many child care facilities have developed and are currently implementing their plans, whereas others are in the beginning phases of developing their plans. Though plans do not need to take the form of this template, providers should ensure that all elements of this template are included in their plans and adjust accordingly. A child care facility's COVID-19 Health and Safety Plan should be shared with all families and posted in a conspicuous area. Child care facilities should also consider whether the adoption of a new policy or the revision of an existing policy is necessary to effectively implement the COVID-19 Health and Safety Plan.

Each child care facility should continue to monitor its COVID-19 Health and Safety Plan throughout the year and update as needed. All revisions should be shared with all families and staff and posted in a conspicuous area. Child care providers are not required to use this specific plan, but the following elements must be addressed in any plan format selected by the provider:

1. Screening procedures,
2. Child drop-off and pick-up policies,
3. Sick policies,
4. Mask policy, and
5. Cleaning/sanitation procedures.

# Successful Family Engagement: Challenges and Opportunities

# Family Engagement Definition

Effective family engagement is *intentional, meaningful and impactful.*


Learning Communities value and support families in their role as a child's first teacher, and *leverage the expertise, knowledge and leadership of families and community partners* to shape the educational environment at the program, classroom, school, state and national level.

These partnerships are *strengths based, culturally responsive and rely on two-way communications.* They focus on the *shared goal* of positive learning and developmental outcomes for children.

- How do you see this definition as relevant during this time...and specifically as providers develop their health and safety plans?
- What does it mean to leverage the expertise, knowledge and leadership of families and their community partners now?
- What would a strengths-based, culturally responsive family engagement strategy look like now?
- Consider the "two way" communication. Families are "getting" a lot of information-but, remember that communication is two-way...for it to be impactful and meaningful families will need to opportunity to influence, provide input, feedback, respond. etc.

# Challenges

- 100% individual
- Social distancing / social isolation

- Increased risk for:
  - child abuse and neglect
  - depression
  - anxiety
  - interpersonal violence



# Opportunities

- Increased desire for connection
- Increased time/availability
- Empower families to use tools and resources readily available
- Leverage families' experience with technology to empower them as leaders and decision makers.
- Emphasize routine over schedule.
- Build on social emotional development of children and attachment between parents and children.
- Empower parents to become stronger observers of children's development and support their children's growth and learning

Frequently communicate with families, addressing learning, social, emotional and physical needs

Parent input related to Health and Safety Plan

Connect families with community resources


Develop and provide peer-to-peer family groups virtually – Communities of Care


