Minimum Requirements to Apply:

- Applicant must be a rising junior or senior
- Applicant must have a minimum GPA of 3.0 in core curriculum classes (English, Science, Math, Social Science, Foreign Language) **at the time of the application deadline**
- Test Scores are **OPTIONAL**:
 - SAT: a minimum of 1050 must be achieved with a minimum score of 24 in Critical Reading and 22 on the Math test.
 - OR
 - ACT: a minimum score of 20 on the Composite section with exempting scores in the English (17) and Math (17) sections.

Cost: Tuition for this program is funded by State revenues. Books will be loaned to students by the college. Only courses approved by the Georgia Student Finance Commission to be Dual Enrollment approved college courses will be covered by State revenues.

Rising juniors are permitted to enroll in one course per semester. Rising seniors are permitted to enroll in a maximum of two courses per semester.

By signing this application, you acknowledge that you are aware of the following:

- Correspondence regarding the course you are enrolled in will be directly through the College of Coastal Georgia.
- You must abide by the policies and procedures the College of Coastal Georgia outlines for visiting and Dual Enrollment students.
- You may not substitute a required Frederica Academy class or credit for a College of Coastal Georgia class.
- Frederica Academy is not responsible for your progress in the course in which you enroll.
- Frederica Academy will send an official high school transcript and copies of official test scores to the College of Coastal Georgia, once you have submitted a formal application to the College.
- **Once this application is submitted, you will be required to complete an official application to the College of Coastal Georgia at www.GAFutures.org, a dual enrollment participation agreement form, and a dual enrollment funding application. An appointment can be made with Mrs. Nevins to complete the applications.**
- Letter grades provided by the College of Coastal Georgia's Registrar will be entered onto Frederica Academy transcripts.

- Letter grades will be calculated into a student's Cumulative GPA using Frederica Academy's grading scale.
- A 0.5 weight will be given to all dual enrollment grades.
- Students will not receive a numeric grade for dual enrollment courses. Therefore, dual enrollment grades will impact a student's cumulative GPA but will not impact a student's cumulative numeric average.
- Only core academic subject courses taken through dual enrollment will be calculated into a student's HOPE Scholarship GPA, as per the Georgia Student Finance Commission's policy.
- Course enrollment is subject to change based on availability and the student's Frederica Academy schedule.
