

FREDERICA ACADEMY BOARD OF VISITORS – BIOGRAPHIES

John Rogers, Chair – John holds a BBA from the University of Georgia and spent 45 years as a banker in Glynn County. He was the President of Atlantic National Bank prior to its acquisition by PrimeSouth Bank in 2017. He is married to Mimi Rogers, a graduate of Duke University and the curator of Coastal Georgia Historical Society. They have two children who both attended Frederica for 13 years: Jarman Rogers '05, a graduate of Dartmouth College, and Ellen Rogers '08, a graduate of the University of Georgia. John was on the FA Board of Trustees for nine years and served as its Chairman. He is a Frederica Academy Trustee Emeritus and currently chairs the Board of Visitors.
