Secretary: Polly Williams



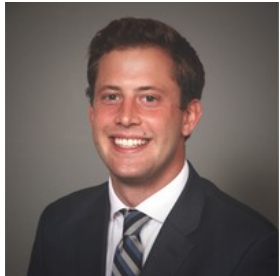
