

-Libby Manning--Libby and Matt Manning Fund-

Libby and Matt Manning have intentionally instilled the value of generosity in their three children. As part of their general education in life-skills, they wanted them to learn the tools available to them to become strong and faithful givers in the community. When their twins graduated in 2022, they talked with them about ways they would give back to the community. This led them to sit down with Kari Sisk, Vice President of Programs at Madison County Community Foundation, to establish the Thomas, Elizabeth, Benjamin Manning Scholarship fund. This fund will be awarded to a graduating Lapel senior every year for generations to come.

The Manning family also established a named unrestricted fund this year. The Libby and Matt Manning Fund is established with the belief that how we care for each other determines the strength of our country and community. With this established fund, the Manning family hopes that the recipients of grants know that many people in the community care about them. Libby says, "I hope that we as a community reclaim a story that says what we do together is far more compelling, imaginative, and worthwhile than anything we do individually. I hope we as a community rise up beyond political differences to care for the well-being of each other, because it is going to take all of us, in our beautiful pluralistic diversity, to build a future worth living into."

Lilly Endowment, Inc. is matching dollars 2:1 through December 31, 2025 and the Manning's decided that it is the perfect time to leverage their philanthropic dollars to receive the match so that more money would be available to address the very real needs in our county. The Madison County Community Foundation has been providing funding to our community since 1992. Grants to community organizations are supported through competitive grants awarded from unrestricted funds in the Foundation.

We create our primary impact through our grantmaking. MCCF currently manages over 200 charitable funds created by individuals, families, businesses, and organizations for charitable purposes. Income from these funds annually provides grants to organizations and projects and programs to improve the quality of life within our community.

Proposals are reviewed by a diverse committee made up of community volunteers and Board Members, which makes funding recommendations to the Foundation Board of Directors. Upon approval by the Board of Directors, funds are awarded.

The Impact Madison Fund is a permanent fund that helps Madison County Community Foundation meet emerging local needs through strategic grantmaking to our nonprofit partners. Grants from this fund reflect Madison County's unique people, issues, and ideas. The Impact Madison Fund helps us support long-term solutions, respond quickly to emergencies, and meet the changing social, cultural, and educational needs our community faces.

SUKE STANDING UP FOR RACIAL EQUITY

Your generosity sparked transformation in a circle of teenagers – making a lasting impact in Madison County.

At Anderson High School this past January, a roomful of students started their day with arms crossed and heads low. But by the time the last bell rang, they were seeing the world, and themselves, in a new light.

This change did not happen by chance. These workshops were fueled through SURE – Standing Up for Racial Equity - and a grant from Madison County Community Foundation.

SURE is a grassroots organization founded in the wake of George Floyd's murder by Angie Strickler and other community leaders. Through the grant that was made possible through unrestricted giving from generous donors, "Implicit Bias for Teens" Workshops were held. These were not lectures, but rather interactive, eyeopening, and conversation-sparking experiences. Led by the skilled educators of the PEACE Learning Center, these workshops gave students tools to recognize unconscious bias in everyday decisions—and the power to challenge it.



Educate. Advocate. Engage.

Because of this grant, the workshops reached more than expected—extending into five full Social Justice Leadership classes rather than just two. Adults are joining the conversation too. A complementary adult workshop brought together community leaders including school board members and a principal, making key decision-makers more aware of the ways implicit bias shapes systems and lives.

On the cusp of starting SURE, Strickler asked herself, "What am I going to do in 20 years when I look back on this time? I have a safe life. Is that my legacy? Is that what I want to be remembered for? Or do I want to change something?"
